## **RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This Release of Security Interest in Trademarks, dated as of September 30, 2014 (the "Trademark Security Release"), is made by MARANON CAPITAL, L.P., in its capacity as agent (in such capacity, the "Agent") under that certain Trademark Security Agreement, dated as of June 7, 2012 (as amended, supplemented or modified and in effect from time to time, the "Trademark Security Agreement") by and among MILTON INDUSTRIES, INC., a Delaware corporation (the "Grantor") and the Agent. Except as otherwise provided herein, capitalized terms used herein but not otherwise defined have the meanings set forth (or incorporated) in the Trademark Security Agreement.

WHEREAS, pursuant to the Trademark Security Agreement which was recorded in the records of the United States Patent and Trademark Office on June 7, 2012 at reel 4797, frame 0258 the Grantor granted to the Agent, for the benefit of the Lenders a security interest in all of Grantor's right, title and interest in, to and under all of its Trademark Collateral, including, without limitation those set forth on the attached Schedule I;

WHEREAS, the Obligations secured by the Trademark Collateral have been repaid; and

WHEREAS, the Grantor has requested and the Agent has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its security interest in the Trademark Collateral (the "Released Collateral").


