RELEASE OF TRADEMARK SECURITY INTEREST

(Griffin Technology, Inc.)

THIS RELEASE OF TRADEMARK SECURITY INTEREST (the "Release") is made effective as of August 18, 2014, by SUNTRUST BANK, as Administrative Agent (the "Administrative Agent") to GRIFFIN TECHNOLOGY, INC. (the "Grantor") as follows:

WHEREAS, the Grantor, certain Subsidiaries of the Grantor, and the Administrative Agent are parties to that certain Third Amended and Restated Security Agreement dated as of December 17, 2013 (as may be amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement") executed in order to secure the prompt and complete payment, observance and performance of all of the Secured Obligations in accordance with the terms and conditions of the various loan documents;

WHEREAS, pursuant to, and in connection with, the Security Agreement, the Grantor granted to the Administrative Agent on behalf of the holders of the Secured Obligations, among other collateral, a continuing security interest in all of the Grantor's right, title and interest, including goodwill, in, to and under the United States Trademarks listed on the attached Schedule A (the "Marks");

WHEREAS, in connection with, and in furtherance of, the granting of a security interest in the Marks, the Grantor has previously executed and delivered to the Administrative Agent (a) that certain Trademark Security Agreement dated as of December 16, 2008 (as recorded with the U.S. Patent & Trademark Office (the "USPTO") on December 16, 2008 at reel 003905, frame 0027) (b) that certain Trademark Security Agreement dated as of November 9, 2011 (as recorded with the USPTO on November 11, 2011 at reel 004660, frame 0218), and (c) that certain Trademark Security Agreement dated as of December 17, 2013 (as recorded with the USPTO on December 31, 2013 at reel 005184, frame 0337) for purposes of filing with the United States Patent and Trademark Office; and

WHEREAS, the Administrative Agent wishes to release its security interest in the Marks.


