Assignor hereby requests the Commissioner of Patents and Trademarks, and the corresponding entities or agencies in any applicable foreign countries, to record Assignee as the assignee and owner of the Marks.

Assignor reiterates the representations and warranties contained in Section 5.9 of the Agreement and incorporates those representations and warranties in this Assignment as if set forth herein.

Assignor shall take all further actions, and provide to Assignee, Assignee's successors, assigns or other legal representatives, all such reasonable cooperation and assistance (including, without limitation, the execution and delivery of any and all affidavits, declarations,

oaths, assignments, powers of attorney or other documentation), requested by Assignee to perfect this Assignment in all applicable jurisdictions throughout the world.
