## RELEASE OF SECURITY INTEREST

This RELEASE, dated as of October 1, 2014 is made by Q LIQUIDATING TRUST F/K/A QUARK HOLDINGS, INC., a Delaware corporation (“Lender”), with reference to that certain Trademark Security Agreement, dated August 1, 2011, executed by QUARK ACQUISITION CORPORATION, a Delaware corporation (“Borrower”) in favor of Lender (as amended, restated, supplemented or otherwise modified from time to time, the “Trademark Security Agreement”), which was recorded with the United States Patent and Trademark Office on December 6, 2013, at reel and frame number 5168/0668. Capitalized terms not defined in this Release shall have the meanings set forth in the Trademark Security Agreement.

For good and valuable consideration, receipt of which is hereby acknowledged, the Lender hereby:

1. releases the security interest granted to Lender by Borrower with respect to all Trademarks described in the Trademark Security Agreement, including, but not limited to, the Trademarks listed on Exhibit A attached hereto (collectively, the “Borrower Trademarks”); and
2. to the extent Lender shall be deemed to have any right, title or interest in the Borrower Trademarks, retransfers and reassigns to Borrower all of such right, title and inters without representation or warranty of any kind whatsoever.

Lender hereby authorizes and requests that the Commissioner for Patents and Trademarks and any other governmental official record this Release. This Release shall be governed by the laws of the State of New York.


