## RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS, dated as of November 4, 2014, is made by **OHA ASSET HOLDINGS, LP** (f/k/a NGPC Asset Holdings, LP), as Noteholder Representative ("**Noteholder Representative**"), having an office at c/o OHA Investment Company, 909 Fannin, Suite 3800, Houston, Texas 77010.

WHEREAS, Noteholder Representative and **R TAPE CORP.**, a Delaware corporation ("**Grantor**"), are parties to that certain Trademark Security Agreement (the "**Agreement**") dated April 22, 2013, recorded on June 18, 2013, in the United States Patent and Trademark Office against various trademarks, commencing at Reel No. 5050, Frame No. 0480; capitalized terms used but not defined herein will have the meaning given to them in the Agreement;


WHEREAS, the Agreement granted to the Noteholder Representative a security interest in all of the Grantor's right, title and interest in, to and under the Trademark Collateral (as defined in the Agreement), including, without limitation: (a) all of Grantor's right, title and interest in and to all of its now or in the future owned or existing Trademarks listed on Schedule I of the Agreement (attached hereto and made a part hereof as Schedule I); (b) all renewals of each of the Trademarks; (c) all income, royalties, damages and payments now and in the future due or payable under, or with respect to, any and all Trademarks, including damages and payments for past or future infringements of any and all Trademarks; (d) all rights to sue for past, present and future infringements of any and all Trademarks; (e) all rights corresponding to each of the Trademarks throughout the world; (f) together in each case with the goodwill of Grantor's business connected with the use of, and symbolized by, the foregoing; and (g) all books, records, cash and non-cash proceeds of any and all of the foregoing, and

WHEREAS, Noteholder Representative now desires to release its security interests granted in the Agreement in the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Noteholder Representative hereby fully and finally releases and terminates (i) its security interest and other rights in, to and under the Trademark Collateral and (ii) any and all other rights it may have under the Agreement.
