TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT

This Termination and Release of Trademark Security Agreement (the "<u>Trademark Release</u>") is conveyed as of November 13, 2014, **MAST SELECT OPPORTUNITIES MASTER FUND L.P.**, as administrative agent for itself and other Lenders (as defined below) under the Credit and Security Agreement referred to below (in such capacity, the "<u>Administrative Agent</u>"), in favor of **NEBRASKA BOOK COMPANY, INC.**, a Delaware corporation (the "<u>Borrower</u>"), individually, the "<u>Grantor</u>". NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which the parties acknowledge, Administrative Agent, for itself and on behalf of the other Secured Parties, hereby releases the Security Interest and hereby waives and relinquishes all its rights, powers, privileges and remedies with respect to the Security Interest.
