TERMINATION OF TRADEMARK SECURITY AGREEMENT

This TERMINATION is executed as of April 5, 2011 by JPMorgan Chase Bank, N.A., as administrative agent for the Lenders (in its capacity as such, the "Administrative Agent"), with reference hereby made to that certain Amended and Restated Credit and Guaranty Agreement dated as of February 13, 2008, as amended and restated as of April 28, 2009, as amended by Amendment No. 1 dated as of December 7, 2010 (as the same may have been further amended, supplemented or otherwise modified, renewed or replaced from time to time, the "Credit Agreement"), among Shine Limited (the "Borrower"), the Guarantors referred to therein (the "Guarantors"), the Lenders referred to therein (the "Lenders"), the Administrative Agent, JPMorgan Chase Bank, N.A. as issuing bank (in such capacity, the "Issuing Bank") and J.P. Morgan Europe Limited as sterling agent (the "Sterling Agent").

WHEREAS, pursuant to the Credit Agreement, certain of the Guarantors (the Borrower and such Guarantors being collectively referred to as the "Pledgors", and individually as a "Pledgor") executed and delivered to the Administrative Agent (for the benefit of itself, the Sterling Agent, the Issuing Bank and the Lenders) the Trademark Security Agreement between the Pledgors and the Administrative Agent, dated as of February 13, 2008 (as supplemented by that certain Supplement No. 1 to the Trademark Security Agreement dated as of April 20, 2009, that certain Supplement to the Trademark Security Agreement dated as of February 10, 2010 and that certain Supplement to the Trademark Security Agreement dated as of February 10, 2010, as the same may have been further amended, supplemented or otherwise modified, renewed or replaced from time to time, the "Trademark Security Agreement");

WHEREAS, pursuant to the terms of the Security Agreement dated as of February 13, 2008 (as the same may be amended, supplemented or otherwise modified, renewed or replaced from time to time, the "Security Agreement") between, among others, the Guarantors party thereto and the Administrative Agent, the Pledgors granted to the Administrative Agent (for the benefit of itself, the Sterling Agent, the Issuing Bank and the Lenders) a security interest in and to all personal property of the Pledgors, including, without limitation, all right, title and interest of the Pledgors in, to and under all of the Pledgors' Trademarks and Trademark licenses to secure the payment and performance of the Obligations (as such term is defined in the Credit Agreement);

WHEREAS, pursuant the Credit Agreement, the Security Agreement and the Trademark Security Agreement, each of the Pledgors granted to the Administrative Agent (for the benefit of itself, the Sterling Agent, the Issuing Bank and the Lenders), as security for the Obligations or for its obligations under and in connection with its guaranty of the Obligations pursuant to the Credit Agreement, as applicable, a continuing security interest in all of such Pledgor's right, title and interest in and to the Trademark Collateral (as defined in the Trademark Security Agreement);

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office at Reel 003735, Frame 0693, on March 10, 2008;

WHEREAS, all Commitments under the Credit Agreement have terminated, Obligations due and owing under the Credit Agreement have been indefeasibly paid in full and no outstanding Obligations remain due and owing and all Letters of Credit have expired or been terminated or cancelled; and

WHEREAS, the Administrative Agent now desires to release and terminate the entirety of its lien upon and security interest in and to the Trademark Collateral and terminate the Trademark Security Agreement.

For good and valuable consideration, receipt of which is hereby acknowledged, the Administrative Agent, for the benefit of itself, the Sterling Agent, the Issuing Bank and the Lenders, hereby:

- (a) terminates the Trademark Security Agreement;
- (b) releases, without recourse, all of its liens upon and security interests in all of the right, title and interest of any Pledgor in, to and under the Trademark Collateral, including the trademark and service mark registrations and applications listed on Schedule A attached hereto (or any security interest in) the Trademark Collateral and/or any goodwill associated with any of the Trademark Collateral, including the trademark and service mark registrations and applications listed on Schedule A attached hereto; and
- (c) to the extent the Administrative Agent shall be deemed to have any right, title or interest in, to or under the Trademark Collateral, without representation or warranty, retransfers and reassigns to the relevant Pledgor(s) all of such right, title and interest solely with respect to any such Trademark Collateral.

Capitalized terms used herein and not otherwise defined herein shall have the meanings given such terms in the Credit Agreement.


This Termination shall be governed by, and construed in accordance with, the laws of the State of New York and shall relate solely to the Trademark Security Agreement.

The Administrative Agent authorizes the recordation of this Termination with the United States Patent and Trademark Office.
