AMENDED AND RESTATED PATENT AND TRADEMARK SECURITY AGREEMENT

This Amended and Restated Patent and Trademark Security Agreement (the "Agreement"), dated as of December 12, 2014 is made by and between THE THYMES, LLC, a Delaware limited liability company having its principal business location at the address set forth on the signature page hereto (the "Company"), and WELLS FARGO BANK, NATIONAL ASSOCIATION, a national banking association having a business location at the address set forth on the signature page hereto ("Wells Fargo").

RECITALS

- A. Company and Wells Fargo are parties to an Amended and Restated Credit Agreement of even date herewith (as amended, supplemented, restated or otherwise modified from time to time, the "Credit Agreement"), setting forth the terms on which Wells Fargo may now or hereafter extend credit to or for the account of Company.
- B. As a condition to extending credit to or for the account of Company, Wells Fargo has required the execution and delivery of this Agreement by Company.

ACCORDINGLY, in consideration of the mutual covenants contained in the Loan Documents and herein, the parties hereby agree as follows:

1. **Definitions**. All terms defined in the Recitals hereto or in the Credit Agreement not otherwise defined herein shall have the meanings given to them in the Credit Agreement. In addition, the following terms have the meanings set forth below:

"Patents" means all of Company's right, title and interest in and to any and all patents or applications for patents, including, (a) the patents and patent applications listed on *Exhibit A* attached hereto, (b) all continuations, divisionals, continuations in part, re-examinations, reissues, and renewals thereof and improvements thereon, (c) all income, fees, royalties, damages and payments now and hereafter due or payable under and with respect thereto, including payments under all licenses entered into in connection therewith and damages and payments for past, present, or future infringements thereof, (d) the right to sue for past, present, and future infringements thereof, and (e) all of Company's rights corresponding thereto throughout the world.

"Security Interest" has the meaning given in Section 2.

"Trademarks" means all of Company's right, title and interest in and to any and all trademarks, trade names, registered trademarks, trademark applications, service marks, registered service marks and service mark applications, including (a) the trade names, registered trademarks, trademark applications, registered service marks and service mark applications listed on *Exhibit B* attached hereto, (b) all renewals thereof, (c) all income, royalties, damages and payments now and hereafter due or payable under and with respect thereto, including payments under all licenses entered into in connection therewith and damages and payments for past or future infringements or dilutions thereof, (d) the right to sue for past, present and future infringements and dilutions thereof, (e) the goodwill of Company's business symbolized by the foregoing or connected therewith, and (f) all of Company's rights corresponding thereto throughout the world.

2. **Security Interest**. Company hereby irrevocably pledges and assigns to, and grants Wells Fargo a security interest (the "Security Interest") with power of sale to the extent permitted by law, in the Patents and in the Trademarks to secure payment of all indebtedness, liabilities and other obligations

of Company to Wells Fargo. As set forth in the Credit Agreement and certain other Loan Documents, the Security Interest is coupled with a security interest in substantially all of the personal property of Company. This Agreement grants only the Security Interest herein described, is not intended to and does not affect any present transfer of title of any trademark registration or application and makes no assignment and grants no right to assign or perform any other action with respect to any intent to use trademark application, unless such action is permitted under 15 U.S.C. § 1060. Notwithstanding the foregoing, the Security Interest shall not extend to any Patents or Trademarks that constitute Excluded Property (as defined in the Borrower Security Agreement).

- 3. **General Rights and Obligations**. Except as expressly set forth herein, the rights and obligations of Company and Wells Fargo with respect to the Patents and Trademarks shall in all respects be governed by the Credit Agreement and the other Loan Documents, the terms of which are incorporated as fully as if set forth at length herein.
- 4. **Amendment and Restatement.** This Agreement constitutes an amendment to, and a complete restatement of, that certain Patent and Trademark Security Agreement dated as of August 3, 2010 between Company and Wells Fargo.
