TRADEMARK ASSIGNMENT AGREEMENT

Assignors' Assignment of Rights: Assignors hereby transfer to Google all right, title, and interest, in and to the CHROME Marks which they, individually or collectively, own together with the goodwill of the business symbolized by the CHROME Marks and any and all trademark registrations and/or applications therefor.
