## AMENDED AND RESTATED TRADEMARK SECURITY AGREEMENT

THIS AMENDED AND RESTATED TRADEMARK SECURITY AGREEMENT (this “Agreement”), dated December 18, 2014, is made by Neenah Paper, Inc., a Delaware corporation, located at 3460 Preston Ridge Road, Suite 600, Alpharetta, GA 30005 (“Assignor”), in favor of JPMorgan Chase Bank, N.A., a national banking association, located at 2200 Ross Avenue, Ninth Floor, Dallas, Texas 75201, Attention: Jennifer Heard, as administrative agent for the Secured Parties (in such capacity, together with any successors and permitted assigns, “Assignee”). Capitalized terms used in this Agreement and not defined herein have the meanings set forth for such terms in the Security Agreement (as hereinafter defined).

WHEREAS, Assignor, each subsidiary of Assignor listed as a “Borrower” on the signature pages thereto, each subsidiary of Assignor listed as a “Guarantor” on the signature pages thereto, the financial institutions from time to time party thereto, Assignee, and JPMorgan Chase Bank, N.A., Toronto Branch, as Canadian collateral agent for the lenders from time to time party thereto (in such capacity, together with any successors and assigns, the “CCA”), were parties to that certain Credit Agreement dated as of November 30, 2004 (as amended, supplemented or otherwise modified prior to November 5, 2009, the “Original Credit Agreement”);

WHEREAS, Assignor, each subsidiary of Assignor listed as a “Borrower” on the signature pages thereto, each subsidiary of Assignor listed as a “Guarantor” on the signature pages thereto, the financial institutions from time to time party thereto, Assignee, and CCA were parties to that certain Amended and Restated Credit Agreement dated as of November 5, 2009 (as amended, supplemented or otherwise modified prior to October 11, 2012, the “Amended and Restated Credit Agreement”), which amended and restated the Original Credit Agreement;

WHEREAS, Assignor, each subsidiary of Assignor listed as a “Borrower” on the signature pages thereto, each subsidiary of Assignor listed as a “Guarantor” on the signature pages thereto, Assignee, and the financial institutions from time to time party thereto are parties to that certain Second Amended and Restated Credit Agreement dated as of October 11, 2012 (as amended, restated, supplemented or otherwise modified from time to time, the “Existing Credit Agreement”), which amended and restated the Amended and Restated Credit Agreement;

WHEREAS, in connection with the Original Credit Agreement, Assignor entered into that certain Trademark Security Agreement, dated November 30, 2004 (as amended from time to time, the “Original Trademark Security Agreement”), in favor of Assignee;

WHEREAS, Assignor, each subsidiary of Assignor referred to as a Loan Party therein, the Lenders, and Assignee are entering into that certain Third Amended and Restated Credit Agreement (as amended, restated and supplemented from time to time, the “Credit Agreement”) of even date herewith to amend and restate the Existing Credit Agreement;

WHEREAS, pursuant to the Credit Agreement, the Lenders have agreed to continue to make certain revolving loans (each a “Loan” and collectively, the “Loans”), and will continue to

provide a subfacility for the issuance of letters of credit to the Borrowers (as defined in the Credit Agreement);

WHEREAS, it is a condition precedent to the Lenders making any Loan or making any other financial accommodation to the Borrowers pursuant to the Credit Agreement that Assignor shall have executed and delivered to the Administrative Agent this Agreement, which amends and restates the Original Trademark Security Agreement;

WHEREAS, Assignor has determined that the execution, delivery and performance of this Agreement directly benefits, and is in the best interest of, Assignor;

WHEREAS, Assignor is the applicant or registrant for the trademarks and service marks listed on the annexed Schedule 1 hereto, which trademarks and service marks are registered or applied for in the United States Patent and Trademark Office (the "Trademarks");

WHEREAS, Assignor has entered into that certain Amended and Restated Security Agreement (Personal Property) dated as of the date hereof among the grantors signatory thereto and Assignee (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement");

WHEREAS, pursuant to the Security Agreement, as collateral security for all of the Secured Obligations, Assignor has pledged and assigned to Assignee, and granted to Assignor, for the benefit of the Secured Parties a continuing security interest in the Trademarks, together with, among other things, the goodwill of the business symbolized by and associated with the Trademarks and the applications and registrations thereof, and all proceeds thereof (the "Collateral");

NOW, THEREFORE, in consideration of the premises and agreements made herein and in the Security Agreement, as collateral security for all of the Secured Obligations, Assignor and Assignee hereby agree to amend and restate the Original Trademark Security Agreement and Assignor hereby pledges and assigns to Assignee, and grants to Assignee, for the benefit of Assignee and the Secured Parties, a continuing security interest in the Collateral.

Assignor does hereby further acknowledge and affirm that the rights and remedies of Assignee with respect to the Collateral are more fully set forth in the Security Agreement, the terms and provisions of which are hereby incorporated by reference herein as if fully set forth herein.

Upon full satisfaction of the Secured Obligations, complete performance of all of the obligations of the Loan Parties under the Loan Documents and final termination of each Lender's obligations – if any – to make any further advances under any promissory note or to provide any other financial accommodations to any Loan Party, all rights under this Agreement shall terminate and the Collateral shall become wholly clear of the security interest evidenced hereby, and upon written request by Assignor such security interest shall be released by Assignee in due form and at Assignor's cost; provided, however, that this Agreement shall be reinstated if at any time any payment of any of the obligations under the Loan Documents is rescinded or must otherwise be returned by Assignee, the Lenders, or any of their respective affiliates or branches

on the insolvency, bankruptcy or reorganization of any Loan Party or otherwise, all as though the payment had not been made.

This Agreement amends and restates the Original Trademark Security Agreement in its entirety. All Liens and security interests, created and granted by the Original Trademark Security Agreement shall continue to exist, remain valid and subsisting, shall not be impaired or released hereby, shall remain in full force and effect and are hereby ratified, affirmed, extended and conveyed as continuing security for the Secured Obligations.

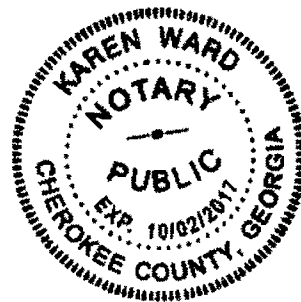
