**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This Release of Security Interest in Trademarks, dated as of December 24, 2014 (the "Trademark Security Release"), is made by LBC CREDIT PARTNERS II, L.P., a Delaware limited partnership, in its capacity as agent (in such capacity, the "Agent") under that certain Trademark Security Agreement, dated as of July 20, 2012 (as amended, supplemented or modified and in effect from time to time, the "Trademark Security Agreement") by and among FOCUS PRODUCTS GROUP INTERNATIONAL, LLC (f/k/a FPG, LLC), an Illinois limited liability company ("Focus" and together with the other grantors named therein, collectively, the "Grantors") and the Agent. Except as otherwise provided herein, capitalized terms used herein but not otherwise defined have the meanings set forth (or incorporated) in the Trademark Security Agreement.

WHEREAS, pursuant to the Trademark Security Agreement which was recorded in the records of the United States Patent and Trademark Office on January 3, 2013 at reel 4933, frame 0878 the Grantors granted to the Agent, for the benefit of the Lenders, a security interest in all of Grantors' right, title and interest in, to and under all of its Trademark Collateral, including, without limitation those set forth on the attached Schedule A;

WHEREAS, the Obligations secured by the Trademark Collateral have been repaid; and

WHEREAS, the Grantor's have requested and the Agent has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its security interest in the Trademark Collateral (the "Released Collateral").

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Agent does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the security interest created under the Trademark Security Agreement in the Released Collateral, (b) release its security interest in the Released Collateral, and (c) discharge any and all rights, title and interest it has in, and the security interest granted to the Agent in the Released Collateral.
