INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

- 2. Ride Group Parent desires to acquire all right, title and interest in and to the Intellectual Property as part of the transaction described above.
- 3. Ride Holdings hereby assigns to Ride Group Parent all right, title and interest in and to the Intellectual Property, including all past actions for infringement and any other enforcement rights that accrue(d) before or after the Effective Date.
- 4. This assignment shall be effective worldwide.
- 5. Ride Holdings promptly shall take any and all actions reasonably requested by Ride Group Parent to effect the purpose of this Agreement.
- 6. The recitals are incorporated herein with full force and effect.
