RECITALS

- A. Grantor, TWINLAB CONSOLIDATED HOLDINGS, INC., a Nevada corporation, TWINLAB CONSOLIDATION CORPORATION, a Delaware corporation, TWINLAB HOLDINGS, INC., a Michigan corporation, TWINLAB CORPORATION, a Delaware corporation, TCC CM SUBCO I, INC., a Delaware corporation, and TCC CM SUBCO II, INC., a Delaware corporation (individually, each a "Company" and collectively, the "Companies") and Grantee are parties to that certain Note and Warrant Purchase Agreement dated November 13, 2014 (as the same may be amended, restated, supplemented, or otherwise modified from time to time, the "Note Purchase Agreement"), pursuant to which Purchaser has agreed to purchase from Companies secured promissory notes.

To secure the payment and performance of the Obligations, and without limiting any other grant of any security interest or lien in any assets of Grantor provided for or created under any other Transaction Document, Grantor hereby grants to Grantee and hereby reaffirms its prior grant pursuant to the Note Purchase Agreement, the Security Agreement and the other Transaction Documents of, a continuing security interest in Grantor's entire right, title and interest in and to the following (all of the following items or types of property being herein collectively referred to as the "Trademark Collateral"), whether now owned or existing and hereafter created, acquired or arising:
 - (a) each Trademark License and Trademark listed on <u>Schedule 1</u> annexed hereto, together with any reissues, continuations or extensions thereof, and all of the goodwill of the business connected with the use of, and symbolized by, each Trademark; and
