RELEASE OF SECURITY INTEREST IN TRADEMARKS, dated as of December 26, 2014 (this "Release"), by JPMORGAN CHASE BANK, N.A., ("JPMCB"), as Administrative Agent, in favor of Brunswick Corporation (the "Borrower"), Brunswick Bowling & Billiards Corporation, Boston Whaler, Inc., Brunswick Commercial & Government Products, Inc., Brunswick Leisure Boat Company, LLC and Lund Boat Company (together with the Borrower, the "Grantors", and each a "Grantor").
