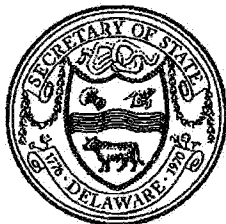

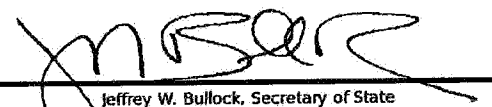

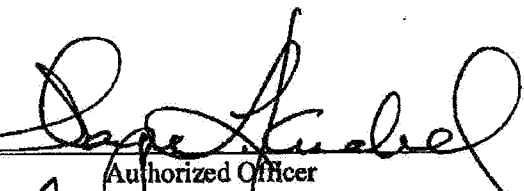

Delaware General Corporation Law
