**TRADEMARK SECURITY AGREEMENT RELEASE**

This TRADEMARK SECURITY AGREEMENT RELEASE (this “*Release*”) dated January 29, 2015, is made by Morgan Stanley Senior Funding, Inc., as collateral agent (together with any successor collateral agent appointed pursuant to the Guarantee and Collateral Agreement, the “*Collateral Agent*”) for the Secured Parties in favor of the Grantors, as defined in the Trademark Security Agreement. All other capitalized terms used herein and not otherwise defined shall have the meaning assigned to such terms in the Guarantee and Collateral Agreement.

WHEREAS, the Grantors entered into that certain Guarantee and Collateral Agreement dated as of April 26, 2013 (as amended, amended and restated, supplemented or otherwise modified from time to time, the “*Guarantee and Collateral Agreement*”) with Morgan Stanley Senior Funding, Inc. as administrative agent;

WHEREAS, pursuant to the terms of the Guarantee and Collateral Agreement, the Grantors executed and delivered that certain Trademark Security Agreement, dated as of April 26, 2013, made by the Grantors to the Collateral Agent (as amended, amended and restated, supplemented, or otherwise modified from time to time, the “*Trademark Security Agreement*”) pursuant to which the Grantors granted to the Collateral Agent, for the ratable benefit of the Secured Parties, a security interest in and to certain intellectual property of the Grantors;

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on May 3, 2013 at Reel 5020 and Frame 0806; and

WHEREAS, in accordance with the provisions of the Guarantee and Collateral Agreement and the Trademark Security Agreement, the Collateral Agent now desire to release its security interest in and to the Trademark Collateral (as defined below).

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby agrees as follows:

SECTION 1. Release of Grant of Security. The Collateral Agent hereby releases to the Grantors its security interest in all of the Grantors’ right, title and interest in and to the following (the “*Trademark Collateral*”):

- (a) all trademarks, service marks, certification marks, tradenames, corporate names, company names, business names, slogans, logos, trade dress, Internet domain names, and other source identifiers, whether registered or unregistered in the United States or any other country or any political subdivision thereof, together with any and all (i) registrations and applications for any of the foregoing, including, without limitation, each registration and application identified on Schedule 1 attached hereto, (ii) goodwill connected with the use thereof and symbolized thereby, (iii) rights and privileges arising under applicable law with respect to the use of any of the foregoing, (iv) extensions and renewals thereof and amendments thereto, (v) income, fees, royalties, damages and payments now and hereafter due and/or payable under or with respect to any of the foregoing, including, without limitation, damages, claims and payments for past, present or future infringements, misappropriations or other violations thereof, (vi) rights and

remedies to sue for past, present and future infringements, misappropriations and other violations of any of the foregoing and (vii) rights, priorities, and privileges corresponding to any of the foregoing throughout the world (“*Trademarks*”) of such Grantor, including, without limitation, the registered and applied for Trademarks of such Grantor listed on Schedule 1 attached hereto; and

(b) to the extent not covered by clause (a), all Proceeds of any of the foregoing.

SECTION 2. Recordation. The Collateral Agent authorizes and requests that the Commissioner for Trademarks and any other applicable government officer record this Release.

SECTION 3. Further Assurances. Collateral Agent shall take all further actions and provide to Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of documents or other instruments), reasonably requested by Grantor to more fully and effectively effectuate the purposes of this Release, at Grantor’s sole expense, and without representation or warranty by Collateral Agent.

SECTION 4. Governing Law. This Release and the rights and obligations of the parties under this Release shall be governed by, and construed in accordance with, the laws of the State of New York.
