## TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of February 11, 2015 (“Release”), is made by Credit Suisse AG, Cayman Islands Branch, as Collateral Agent (“Collateral Agent”), in favor of Aspen Education Group, Inc., a California corporation, Mount Bachelor Education Center, Inc., an Oregon corporation, CRC Health Corporation, a Delaware corporation, Sierra Tucson, Inc., a Delaware corporation, and CRC Health Group, Inc., a Delaware corporation (each a “Grantor” and together, the “Grantors”).

**WHEREAS**, pursuant to that certain Security Agreement dated as of March 28, 2014 (as amended, restated, supplemented, modified, extended, renewed or replaced from time to time, the “Security Agreement”) by and among the Grantors, Collateral Agent, and others party thereto and the Trademark Security Agreement dated as of March 28, 2014 (“Trademark Security Agreement”) by and among the Grantors and Collateral Agent, Grantors granted to the Collateral Agent, for the benefit of the Secured Parties, a security interest in or to any and all of Grantors’ right, title and interest in, to and under the Owned Trademarks; and

**WHEREAS**, the Trademark Security Agreement was recorded at the United States Patent and Trademark Office (“USPTO”) on April 2, 2014 at Reel 5249 Frame 0749.

**NOW THEREFORE**, in consideration of the mutual promises and undertakings set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and with the intention of being legally bound hereby, Collateral Agent, on behalf of the Secured Parties, and Grantors agree as follows:

**SECTION 1. Defined Terms.** Capitalized terms used herein without definition shall have the meanings ascribed to such terms in the Security Agreement or Trademark Security Agreement.

**SECTION 2. Termination and Release.** Collateral Agent, on behalf of the Secured Parties, hereby:

(a) absolutely, unconditionally and irrevocably terminates the Trademark Security Agreement, and any other agreement under which any Grantor has granted a collateral mortgage, pledge, hypothecation, grant, assignment, lien, or security interest in, to, and under the Owned Trademarks;

(b) absolutely, unconditionally and irrevocably terminates, cancels, forever discharges, and releases the mortgage, pledge, and hypothecation and lien on and security interest in and to the right, title, and interest in, to, and under the Owned Trademarks, including, but not limited to, the foregoing listed on Schedule A attached hereto; and

(c) authorizes the recordation of this Release with the USPTO at Grantors’ expense.

**SECTION 3. Further Assurances.** Collateral Agent, at Grantors’ expense, hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the security interest release contemplated herein. To the extent that any other filings with any other governmental authority have been made with respect to any of the Owned Trademarks, Collateral Agent will, at Grantors’ expense, execute and deliver a reasonable release or other instrument that will terminate any such filing and/or release any interests conveyed therein.

**IN WITNESS WHEREOF**, the Collateral Agent, on behalf of the Secured Parties, has caused this Termination and Release of Security Interest in Trademarks to be duly executed as of the date first set forth above.
