WHEREAS, Assignor has adopted, used, is using and has acquired goodwill associated with and symbolized by said Trademarks and has not abandoned the same; and



Assignor will assist Assignee as reasonably necessary to secure, perfect, maintain or evidence the rights hereby transferred. Assignor hereby appoints Assignee's in-house counsel as Assignor's attorney-in-fact to execute all documents on behalf of Assignor and its employees for this limited purpose. Assignor hereby requests that any appropriate patent, trademark or other government offices record this Assignment and issue a new certificate of registration in the Assignee's name.
