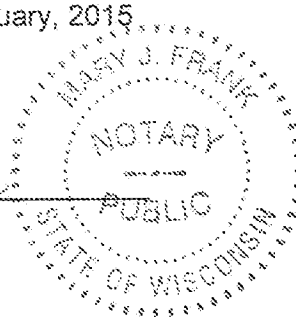

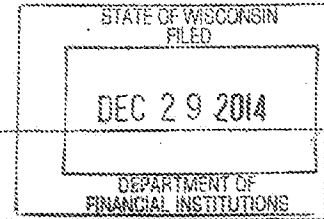



1. Name and State of Formation before Conversion. The name of the company is Kimberly-Clark Worldwide, Inc. ("the Company") and it is a corporation governed by and incorporated in accordance with the laws of the State of Delaware.

2. Name and State of Formation after Conversion. The Company shall continue its existence as a corporation to be known as Kimberly-Clark Worldwide, Inc., and it shall convert its state of incorporation to be governed by and organized in accordance with the laws of the State of Wisconsin.

3. Conversion.

(a.) The Company shall convert into Kimberly-Clark Worldwide, Inc., a Wisconsin corporation ("K-C Worldwide") and shall exist by virtue and in accordance with the laws of the State of Wisconsin (the "Conversion").

(b.) From and after the Effective Date (as defined below), the existence, purpose, powers, franchises, rights and immunities of the Company shall continue unaffected and unimpaired by the Conversion and it shall continue its existence as K-C Worldwide, a corporation governed by and organized in accordance with the laws of the State of Wisconsin. Upon the Effective Date, the Company shall cease to exist as a corporation in accordance with the laws of the State of Delaware.

(c.) The Company shall not be required to wind up its affairs, or pay its liabilities and distribute its assets, as a result of the Conversion and the Conversion shall not constitute a dissolution of the Company, but shall constitute a continuation of the existence of the Company in the form of K-C Worldwide.

4. Manner of Converting Shares. On the Effective Date, as a result of the Conversion, each issued and outstanding share of common stock of the Company shall be exchanged for an identical number of shares of common stock of K-C Worldwide.

5. Effective Date. The Conversion shall become effective on January 1, 2015 (the "Effective Date").

6. Articles of Incorporation. The Articles of Incorporation of K-C Worldwide are attached as Exhibit B to the Certificate of Conversion.

7. Directors. On the Effective Date, the Company's directors immediately prior to the Effective Date shall become the directors of K-C Worldwide.

8. Officers. On the Effective Date, the Company's officers immediately prior to the Effective Date shall become the officers of K-C Worldwide in the capacities they respectively served while with the Company.

9. Approval of Plan. Upon approval and adoption by the Company's Board of Directors and sole shareholder of this Plan of Conversion and any other documents, instruments and agreements required, necessary or appropriate to effectuate the Conversion, a Certificate of Conversion shall be executed, filed and recorded in accordance with the Wisconsin Business Corporation Law and a Certificate of Conversion shall be executed, filed and recorded in accordance with the General Corporation Law of the State of Delaware (collectively, the "Certificate of Conversion") upon such date as determined by any officer of the Corporation.

10. Abandonment of Plan. Notwithstanding anything contained herein to the contrary, this Plan of Conversion may be terminated and abandoned by the Board of Directors of the Company at any time prior to the filing of the Certificates of Conversion if the Board of Directors of the Company should decide that it would not be in the best interests of the Company to effectuate such Conversion.

ARTICLES OF INCORPORATION

ARTICLE I

The name of the corporation is Kimberly-Clark Worldwide, Inc.

ARTICLE II

The period of existence of the corporation shall be perpetual.

ARTICLE III

The corporation is authorized to engage in any lawful activity for which corporations may be organized under Chapter 180 of the Wisconsin Statutes.

ARTICLE IV

The aggregate number of shares which the corporation shall have authority to issue is One Thousand One Hundred (1,100) shares of stock consisting of One Thousand (1,000) shares of common stock, without par value (the "Common Stock") and One Hundred (100) shares of preferred stock, without par value (the "Series A Preferred Stock").

The respective preferences, limitations, designations and relative rights of the classes of stock which the Corporation is authorized to issue are as follows:

A. Series A Preferred Stock.

The rights, preferences, privileges and restrictions granted to and imposed on the Series A Preferred Stock are as set forth below in this Article IV(A):

(1) Dividend Provisions. The holders of shares of Series A Preferred Stock shall be entitled to receive cumulative cash dividends, out of any assets legally available therefor at the rate of 8.0% per annum of the Liquidation Preference (as defined herein) plus accumulated and unpaid dividends thereon from and including the date of issuance to and including the date of any liquidation, dissolution or winding up of the Corporation. Such dividends will accrue whether or not they have been declared and whether or not there are profits, surplus or other funds of the Corporation legally available for the payment of dividends. To the extent not paid on March 30, June 30, September 30 and December 30 of each year (the "Dividend Reference Dates"), all dividends which have accrued on each share of Series A Preferred Stock outstanding during any three-month period (or shorter period in the case of the initial Dividend Reference Date) shall be accumulated and shall remain accumulated dividends with respect to each such share of Series A Preferred Stock until paid. If at any time the Corporation pays less than the total

amount of dividends then accrued with respect to the Series A Preferred Stock, such payment will be distributed ratably among the holders of the Series A Preferred Stock on the basis of the number of shares of Series A Preferred Stock owned by each such holder. The Corporation may not pay any dividend on shares of Common Stock if at the time of such payment there shall be any accumulated and unpaid dividends on the shares of Series A Preferred Stock. The holders of shares of Series A Preferred Stock shall not be entitled to receive any dividends declared or paid on shares of Common Stock.

(2) Liquidation Preference.

(a) In the event of any liquidation, dissolution or winding up of the Corporation, either voluntary or involuntary, the holders of the Series A Preferred Stock shall be entitled to receive for each outstanding share of Series A Preferred Stock, prior and in preference to any distribution of any of the assets of the Corporation to the holders of the Common Stock by reason of their ownership thereof, an amount equal to (i) one hundred eighty-nine thousand and five hundred ninety-five and 74/100 dollars (\$189,595.74) (the "Liquidation Preference"), plus (ii) all accrued and unpaid dividends on such Series A Preferred Stock (as adjusted for any stock dividends, combinations, splits, recapitalizations and the like with respect to such shares) for each share of Series A Preferred Stock held by them. If upon the occurrence of such event, the assets and funds thus distributed among the holders of the Series A Preferred Stock shall be insufficient to permit the payment to such holders of the full aforesaid preferential amount, then the entire assets and funds of the Corporation legally available for distribution shall be distributed ratably among the holders of the Series A Preferred Stock in proportion to the amount of such stock owned by each such holder.

(b) Upon the completion of the distribution required by subparagraph (a) of this Section 2, the remaining assets of the Corporation available for distribution to stockholders shall be distributed among the holders of the Common Stock pro rata in proportion to the number of shares of Common Stock held by each such holder.

(c) (i) For purposes of this Section 2, a liquidation, dissolution or winding up of the Corporation shall be deemed to be occasioned by, and to include, without limitation, a sale of all or substantially all of the assets of the Corporation.

(ii) In any of such events, if the consideration received by the Corporation is other than cash, its value will be deemed its fair market value. Any securities received as consideration shall be valued as follows:

(A) Securities not subject to investment letter or other similar restrictions on free marketability shall be valued as follows:  
(1) if traded on a securities exchange or through the Nasdaq National Market, the value shall be deemed to be the average of

the closing prices of the securities on such exchange over the thirty (30) day period ending three (3) days prior to the closing; (2) if actively traded over-the-counter, the value shall be deemed to be the average of the closing bid of sale prices (whichever is applicable) over the thirty (30) day period ending three (3) days prior to the closing; and (3) if there is not active public market, the value shall be the fair market value thereof, as determined in good faith by the Board of Directors of the Corporation.

(B) Securities subject to investment letter or other restrictions on free marketability (other than restrictions arising solely by virtue of a stockholder's status as an affiliate or former affiliate) shall be valued in such a manner as to make an appropriate discount from the market value determined as above in (A)(1), (2) or (3) to reflect the approximate fair market value thereof, as determined in good faith by the Board of Directors of the Corporation.

(iii) In the event the requirements of this subsection 2(c) are not complied with, the Corporation shall either:

(A) cause such closing to be postponed until such time as the requirements of Section 2 have been complied with; or

(B) cancel such transaction, in which event the rights, preferences and privileges of holders of the Series A Preferred Stock shall revert to and be same as such rights, preferences and privileges existing immediately prior to the date of the first notices referred to in subsection 2(c)(v) hereof.

(iv) The Corporation shall give each holder of record of the Series A Preferred Stock written notice of such impending transaction no later than ten (10) days prior to the stockholder meeting called to approve such transaction, or ten (10) days prior to the closing of such transaction whichever notice date is earlier. The provisions of this subsection 2(c)(iv) may be waived upon the written consent of the holders of at least a majority of the then outstanding shares of Preferred Stock.

(3) Voting Rights. Except as may be provided by applicable law, the holders of the Series A Preferred Stock shall have no voting rights.

B. Common Stock.

(1) Dividend Rights. The holders of shares of Common Stock shall be entitled to dividends, when and as declared by the Board of Directors, as the same may be permitted by law.

(2) Liquidation Preference. The holders of shares of Common Stock shall be entitled to receive, in proportion to the number of shares of common stock held, the net assets of the Corporation upon dissolution after any preferential amounts required to be paid or distributed to holders of outstanding shares of Preferred Stock, if any, are paid or distributed.

(3) Voting Rights. Except as may be provided by applicable law, each share of Common Stock shall entitle the holder thereof to one (1) vote on each matter submitted to a vote of the stockholders.

#### ARTICLE V

The registered office of the corporation is located at ~~802~~Excelsior Drive, Suite 200, Madison, Wisconsin 53717 and the name of its registered agent at such address is C T Corporation System.

#### ARTICLE VI

The number of directors constituting the initial Board of Directors of the corporation shall be as provided in the By-Laws of the corporation. The number of directors of the corporation may be changed from time to time by the directors then in office, but in no case shall be less than one (1).

#### ARTICLE VII

Informal Action by Shareholders. Any action required or permitted to be taken at a meeting of the shareholders may be taken without a meeting if one or more written consents, setting forth the action so taken, are signed by shareholders who would be entitled to vote with respect to the subject matter thereof with voting power to cast the number of votes that would be necessary to authorize or take the action at a meeting at which all shares entitled to vote are present and voted; and are delivered to the Corporation for inclusion in the minute book.


