Re: Amended and Restated Loan and Security Agreement dated as of November 5, 2004 (as amended, supplemented or otherwise modified to date, the "Loan Agreement"), by and among Idea Sphere, Inc., Twinlab Corporation, Natural2U LLC, Health Med, Inc., Med Letter, Inc., Natural Pet Nutrition, L.L.C., 701 Corporation, ISI Brands, Inc., Health Letter, Inc. and TGI Organic, LLC (collectively, the "Borrowers"), CapitalSource Finance LLC, as agent ("Agent") for the lenders party thereto ("Lenders") and the Lenders.

Ladies and Gentlemen:

Reference is hereby made to the Loan Agreement described above. Capitalized terms used but not defined herein shall have the meanings given them in the Loan Agreement.

Borrowers and Mark Fox, Peter Lusk, William Nicholson, Anthony Robbins and Dave Van Andel (collectively the "Guarantors") have advised Agent and Lenders that Borrowers will, on or prior to 2:00 p.m. (eastern time) on January 7, 2008 (such date and time, the "Payoff Deadline") repay the outstanding Obligations due to Agent and Lenders with the proceeds of loans to Borrowers from Fifth Third Bank ("New Lender"). The aggregate amount of the Obligations is set forth as the "Total Payoff Amount" on Schedule 1 hereto ("Total Payoff Amount"), which includes a reserve in the amount of \$15,000 ("Reserve") to reimburse Agent and Lenders for legal fees and other expenses which were not ascertainable as of the Payoff Deadline.

Borrowers hereby acknowledge and agree that if the Total Payoff Amount (including any per diem amounts accruing from and after January 7, 2008) is not received by Lender by the Payoff Deadline, the Total Payoff Amount set forth in this letter agreement shall have no force or effect, and neither Agent nor Lenders shall be bound hereby and Borrowers and New Lender shall not be entitled to rely hereon.

Agent represents to Borrowers and New Lender that Agent is the holder of the Loan Documents and has the right and power to authorize the termination of the Loan Documents and all security

documents associated therewith, including, but not limited to, those listing D.B. Zwirn Special Opportunities Fund, L.P. as party or secured party. Upon Agent's receipt of the Total Payoff Amount in immediately available funds prior to the Payoff Deadline and receipt by Agent of a copy of this letter agreement executed by Borrowers and Guarantors: (i) all liabilities, obligations and indebtedness (other than Continuing Obligations and Indemnity Obligations (defined below) then owing by Borrowers and Guarantors to Agent and Lenders shall have been paid in full, (ii) all documents giving rise to such liabilities, obligations and indebtedness shall be terminated except to the extent provisions therein survive termination by their terms; (iii) all mortgages, security interests and liens granted to Agent in any and all of the property of Borrowers shall automatically and forever terminate; (iv) Agent authorizes without any further act or consent Borrowers and New Lender to prepare and file any and all releases and terminations necessary to terminate any and all UCC financing statements or other Loan Documents filed against Borrowers by or on behalf of Agent, and Agent agrees to promptly execute all lien releases to give effect thereto upon Borrowers' or New Lender's written request and at Borrowers' expense, including, but not limited to, releases with respect to all filings made with the U.S. Patent and Trademark Office and any other filing offices; (v) Agent will promptly deliver to New Lender any and all items of collateral or certificates thereof held by Agent, including, but not limited to, stock certificates in any Borrower or any subsidiary of any Borrower; and (vi) Agent will, at Borrowers' expense, take such further acts as may be deemed necessary or appropriate by Borrowers or New Lender in connection with the payoff of the indebtedness, liabilities and obligations owing to Agent and Lenders and the release of Agent's liens.

Notwithstanding anything to the contrary contained herein, Borrowers and Guarantors are not released from, and hereby ratify and confirm their continuing liability to Agent and Lenders for the indefeasible payment and satisfaction in full of the following (collectively, "Continuing Obligations"): (i) any and all indemnity obligations under any of the Loan Documents not yet due and payable and which by their terms survive the termination of the Loan Documents (collectively, the "Indemnity Obligations"); and (ii) interest (at the interest rate provided for in the Loan Agreement) upon all amounts owed to Agent or Lenders in respect of the Continuing Obligations, which interest shall accrue from the date on which each such amount is due under the terms of the Loan Documents as in effect immediately prior to the effectiveness hereof, until Agent and Lenders have received full and final payment thereof in immediately available funds. In the event any payment made to, or other amount or value received by Agent or Lenders from or for the account of Borrowers or Guarantors is avoided, rescinded, set aside or must otherwise be returned or repaid by Agent or Lenders whether in any bankruptcy, reorganization, insolvency or similar proceeding involving Borrowers, any of their subsidiaries, Guarantors or otherwise, the indebtedness intended to be repaid thereby shall be reinstated (without any further action by any party); provided that no liens or security interests securing such indebtedness shall be reinstated. In such event, Borrowers and Guarantors shall, be and remain liable to Agent and Lenders for the amount so repaid or recovered to the same extent as if such amount had never originally been received by Agent or Lenders with interest accruing thereon from and after the date such amount is so repaid or recovered. Within thirty (30) days of the receipt by Agent of the Total Payoff Amount, Agent shall remit to Borrowers the amount, if any, of the remaining Reserve after deduction of all fees and costs incurred by Agent or Lenders not ascertainable as of the Payoff Deadline.

By execution of this letter agreement, Borrowers and Guarantors acknowledge and confirm that they do not have any offsets, defenses, recoupments, claims or counterclaims against Agent, Lenders, or any of their direct or indirect parent companies, present and former affiliates and subsidiaries, predecessors in interest, present and former officers, agents, directors, members, managers, attorneys and employees, and the respective heirs, executors, successors and assigns of all of the foregoing, whether past, present or future (collectively with Agent and Lenders, the

**“Lender Affiliates”), whether asserted or unasserted. To the extent that they may have such offsets, defenses, recoupments, claims or counterclaims, Borrowers and Guarantors and each of their successors, assigns, affiliates, predecessors, employees, agents, heirs, executors, directors, officers, shareholders and subsidiaries, whether past present or future (collectively with Borrowers and Guarantors, the “Borrower Affiliates”) as applicable, jointly and severally, release and forever discharge Agent, Lenders and the Lender Affiliates, of and from any and all manner of action and actions, cause and causes of action, suits, debts, torts, controversies, damages, judgments, executions, recoupments, claims and demands whatsoever, asserted or unasserted, in law or in equity which, against Agent, Lenders and/or the Lender Affiliates, they ever had, now have or which Borrower Affiliates ever had or now has, upon or by reason of any matter, cause, causes or thing whatsoever, including, without limitation, any presently existing claim, recoupment or defense, whether or not presently suspected, contemplated or anticipated.**

Borrowers and Guarantors represent and warrant that (i) they are represented by legal counsel of its choice, are fully aware of the terms and contained in this letter agreement and have voluntarily and without coercion or duress of any kind entered into this letter agreement and documents executed in connection with this letter agreement or (ii) they have knowingly and intentionally waived their right to have legal counsel of its choice review and represent them with respect to the negotiation and preparation of this letter agreement.

This letter agreement shall be governed by, and construed in accordance with, the laws of the State of Maryland, without reference to the conflicts or choice of law principles thereof. THE PARTIES TO THIS LETTER AGREEMENT WAIVE ANY RIGHT TO A JURY TRIAL WITH RESPECT TO ANY MATTER RELATING HERETO OR TO ANY OTHER LOAN DOCUMENT. This letter agreement may be executed in any number of counterparts and by different parties hereto in separate counterparts, and by facsimile, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same letter agreement.
