CONFIRMATION OF TRADEMARK SECURITY INTEREST ASSIGNMENT

This Confirmation of Trademark Security Interest Assignment (the “Confirmation Agreement”), dated as of March 13, 2015, is made by Performance Fibers Holdings Finance, Inc., a Delaware corporation (in such capacity, the “Assignor”), in favor of DFT DuraFiber Technologies Holdings, Inc., a Delaware corporation (in such capacity, the “Assignee”).

WHEREAS, pursuant to that certain Amended and Restated Grant of Security Interest in Trademark Rights, dated as of May 8, 2009 (as amended, supplemented or otherwise modified from time to time, the “Trademark Security Agreement”) between Performance Fibers Operations, LLC, a Delaware limited liability company (f/k/a Performance Fibers Operations, Inc.) (“PFO”) and the Assignor, PFO pledged and granted to the Assignor a continuing security interest in, among other things, the Trademarks (as defined below);

WHEREAS, an executed copy of the Trademark Security Agreement was recorded in the United States Patent and Trademark Office at reel 3985, frame 0312;

WHEREAS, the Assignor has agreed to assign its security interest in the trademarks, trademark applications and trademark registrations, identified on Schedule A attached hereto (the “Trademarks”), to the Assignee; and

WHEREAS, Assignor and Assignee desire to record the transfer of security interest in the aforesaid Trademarks from the Assignor to the Assignee in the United States Patent and Trademark Office.

NOW THEREFORE, Assignor and Assignee hereby confirm that, effective as of March 13, 2015, Assignor assigned and does hereby assign to Assignee, its successors and assigns, Assignor’s security interest in the Trademarks.

Assignor hereby authorizes the appropriate empowered officials in the appropriate governmental offices in jurisdictions throughout the world to transfer Assignor’s security interest in the Trademarks to Assignee as assignee in accordance with this instrument of assignment. Further, Assignor shall take all additional steps necessary, including the execution of any additional documents and instruments reasonably requested by Assignee, in order to effect or memorialize the intent of this Confirmation Agreement.

Assignor represents that it has the authority to make and enter into this Confirmation Agreement.

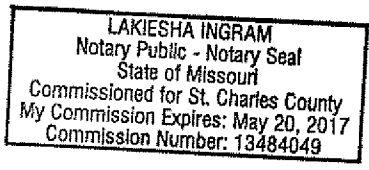


