TRADEMARK ASSIGNMENT

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, ASSIGNOR has sold, assigned, transferred and set over, and does, by this Assignment, sell, assign, transfer, and set over unto ASSIGNEE, its successors, legal representatives and assigns, ASSIGNOR's entire right, title and interest in and throughout the United States of America and its territories, in and to the Trademarks and said registrations (including any common law rights that may exist and are associated therewith), together with the goodwill symbolized by and appurtenant to the Trademarks, and all claims for damages, payments and profits for infringement and unauthorized use, with the right to sue for and collect the same for the sole use and benefit of ASSIGNEE, its successors, legal representatives and assigns.

ASSIGNOR agrees, without further consideration but at ASSIGNEE's sole expense, to take such actions, including without limitation the execution, acknowledgment and delivery of documents, as may be necessary, appropriate or reasonably requested by ASSIGNEE to further effectuate the assignment contemplated herein. ASSIGNOR further authorizes the Director of the United States Patent and Trademark Office to record the Trademarks and Registrations and title thereto as the property of ASSIGNEE, its successors, legal representatives and assigns in accordance with the terms of this instrument.
