Pursuant to the provisions of Article 5.16 of the Texas Business Corporation Act, Schlumberger Technology Corporation, a corporation organized under the laws of the State of Texas and owning 100% of the issued ten thousand (10,000) shares of Dowell Schlumberger Incorporated, a corporation organized under the laws of the State of Delaware, hereby executes the following Articles of Merger:

1. The following is a copy of the resolutions adopted by the unanimous written consent of the Board of Directors of Schlumberger Technology Corporation on the 20th day of December, 1994:

"RESOLVED, that Schlumberger Technology Corporation ("this Corporation"), merge, and it hereby does merge into itself, effective on the 31st day of December, 1994 said Dowell Schlumberger Incorporated and assumes all its obligations; and

RESOLVED, that effective upon the merger of Dowell Schlumberger Incorporated into this Corporation, there be established a division of this Corporation known as the Dowell Division and that the officers of the said division shall be:

L. E. Brumit	-	President
Bernard Vaucher	-	Treasurer/Controller

RESOLVED, that the appropriate officers of this Corporation be, and each of them hereby is, authorized and directed to make, execute and deliver, in the name of this Corporation, any documents required to effect the above-described merger, including but not limited, to a Certificate of Ownership and Merger or Articles of Merger setting forth a copy of the resolutions to merge said Dowell Schlumberger Incorporated and assume its liabilities and obligations."

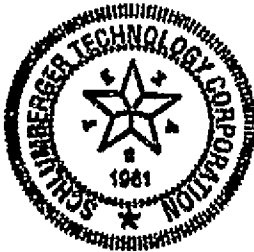

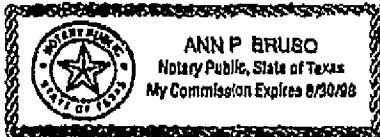
