ment.

- 2.3 Assignor covenants that, at the cost and request of Assignee at any time and from time to time it will execute such deeds or documents and do such acts or things as may be necessary or desirable to give effect to this Assignment.

ARTICLE 3 -- AUTHORIZATION

- 3.1 Assignor hereby authorizes and requests the Trademark Offices in any jurisdiction to record the transfer of the registrations and/or applications of the Trademarks to Assignee by registering Assignee as the registered proprietor of the Trademarks.




