**TERMINATION AND RELEASE OF  
SECURITY INTEREST IN TRADEMARKS**

WHEREAS **Community Connect, Inc.**, a Delaware corporation with principal offices at 850 Third Avenue, 3<sup>rd</sup> Floor, New York, New York 10022 (the “CCI Grantor”), entered into a certain Grant of Security Interest in United States Trademarks dated March 31, 2011 (the “CCI Grant”) in favor of **Credit Suisse AG**, with principal offices at One Madison Avenue, New York, New York 10010 (the “Collateral Agent”), notice of which was recorded on April 19, 2011 at the United States Patent and Trademark Office at Reel 4524, Frame 0657.

WHEREAS **Radio One, Inc.**, a Delaware corporation with principal offices at 5900 Princess Garden Parkway, 7th Floor, Lanham, Maryland 20706 (the “ROI Grantor”), entered into a certain Grant of Security Interest in United States Trademarks dated March 31, 2011 (the “ROI Grant”) in favor of **Credit Suisse AG**, notice of which was recorded on April 19, 2011 at the United States Patent and Trademark Office at Reel 4524, Frame 0679.

WHEREAS **Reach Media, Inc.**, a Texas corporation with principal offices at 13760 Noel Road, Suite 750, Dallas, Texas, 75240 (the “RMI Grantor”), entered into a certain Grant of Security Interest in United States Trademarks dated February 13, 2013 (the “RMI Grant”) in favor of **Credit Suisse AG**, notice of which was recorded on February 14, 2013 at the United States Patent and Trademark Office at Reel 4963, Frame 0177.

WHEREAS, CCI Grantor, ROI Grantor, RMI Grantor, the other grantors from time to time party thereto and the Collateral Agent entered into a certain Security Agreement, dated March 31, 2011 (as amended, modified, restated and/or supplemented from time to time, the “Security Agreement”).

WHEREAS, to secure the payment of all the Obligations of Grantors (as such term is defined in the Security Agreement), each of CCI Grantor, ROI Grantor and RMI Grantor (each, a “Grantor,” and collectively, the “Grantors”) granted the Collateral Agent, under the terms of the Security Agreement, a continuing security interest in (i) all of Grantor’s rights, title and interest in, to and under the trademarks, trademark registrations and trademark applications listed in Schedule A, Schedule B and Schedule C (collectively, the “Trademarks”) in each case together with (ii) all Proceeds (as such term is defined in the Security Agreement) and products of the Trademarks, (iii) the goodwill of the businesses with which the Trademarks are associated, and (iv) all causes of action prior to or after the date thereof for infringement of any of the Trademarks or unfair competition regarding the same ((i)-(iv), the “Trademark Collateral”).


WHEREAS, the Collateral Agent acknowledges payment of all of the Obligations of the Grantors, and thus has agreed to terminate and release its security interests in all Trademark Collateral as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Collateral Agent, for itself and on behalf of the lenders in association with the Security Agreement, hereby (a) releases, terminates and discharges (i) any and all of its security

interest in the Trademark Collateral, and all of the goodwill of the business connected with the use of, and symbolized by the Trademarks, and (ii) the CCI Grant, ROI Grant, and RMI Grant; and (b) reassigns to Grantor any and all rights, title and interest it may have in the Trademark Collateral.


