THIS AGREEMENT IS SUBORDINATED TO THE "SENIOR DEBT" (AS DEFINED IN THE INTERCREDITOR AGREEMENT REFERRED TO BELOW) IN THE MANNER AND TO THE EXTENT SET FORTH IN THE INTERCREDITOR AGREEMENT OF EVEN DATE HERewith BY AND AMONG NORTHBROOK BANK & TRUST COMPANY, AQUATROLS CORPORATION OF AMERICA, AQUATROLS HOLDING COMPANY, INC., AQUATROLS EUROPE LTD. AND ALDINE CAPITAL FUND II, L.P., TO WHICH REFERENCE IS MADE FOR THE TERMS OF SUCH SUBORDINATION AND FOR LIMITATIONS ON ENFORCEMENT OF THE PROVISIONS HEREOF AND OF RETENTION OF PAYMENTS RECEIVED HEREUNDER.

SUBORDINATED INTELLECTUAL PROPERTY SECURITY AGREEMENT

This SUBORDINATED INTELLECTUAL PROPERTY SECURITY AGREEMENT (this "Agreement") dated as of April 22, 2015 (the "Effective Date"), is executed by AQUATROLS CORPORATION OF AMERICA, a Delaware corporation, with its chief executive office located at 1273 Imperial Way, Paulsboro, New Jersey, 08066 (the "Borrower"), AQUATROLS HOLDING COMPANY, INC., a Delaware corporation, with its chief executive office located at 1105 N. Market St., Suite 1300, Wilmington, DE 19801 ("Holding"), and AQUATROLS EUROPE, LTD., a private company registered in England, with its chief executive office located at c/o MacIntyre Hudson, New Bridge Street House, 30-34 New Bridge St., London, England, EC4V 6BJ UK ("Aquatrols UK", and together with Borrower and Holding, individually and collectively, and jointly and severally, as the context requires, the "Obligor"), in favor of ALDINE CAPITAL FUND II, L.P., a Delaware limited partnership and Federal licensee under the Small Business Investment Act of 1958, as amended, whose address is 30 West Monroe Street, Suite 710, Chicago, Illinois 60603 (the "Lender").

RECITALS

A. The Obligor and the Lender have entered into that certain Senior Subordinated Loan and Security Agreement dated the Effective Date (the "Loan Agreement"). All capitalized terms not otherwise defined herein will have the meanings ascribed to them in the Loan Agreement, the applicable provisions of which are incorporated herein by this reference.

B. The Obligor has determined that it is in its best interests to enter into the Loan Agreement. The Lender, however, will not enter into the Loan Agreement unless the Obligor executes and delivers this Agreement and pledges to the Lender, a security interest in the Pledged Collateral (as defined herein) in order to secure the payment and performance by the Obligor of the Secured Liabilities (as defined below).

CLAUSES

To induce the Lender to enter into the Loan Agreement, the Obligor hereby agrees as follows:

1. Grant of Security Interests. To secure the complete and timely payment and satisfaction of the Obligations, and any other indebtedness, obligations and liabilities of whatsoever kind and nature of the Obligor (whether arising before or after the filing of a petition in bankruptcy), whether direct or indirect, absolute or contingent, due or to become due, and whether now existing or hereafter arising and howsoever held, evidenced or acquired, and whether several, joint or joint and several, and (b) any and all expenses and charges, legal or otherwise, suffered or incurred by the Lender in collecting or enforcing any of such indebtedness, obligations or liabilities or in realizing on or protecting or preserving any security therefor, including, without limitation, the lien and security interest granted hereby (the "Secured Liabilities"), the Obligor hereby grants to the Lender, a continuing perfected

security interest in all of the following property of Obligor (collectively, the "Pledged Collateral") subject only to the Lien of the Senior Lender securing the Senior Bank Debt, whether now owned or existing or hereafter acquired:

(a) Trademarks, service marks, assumed or fictitious trade names, trade styles, logos, other business identifiers, prints and labels on which any of the foregoing have appeared or appear, all registrations and recordings thereof and all applications in connection therewith, including, without limitation, those listed on Exhibit A attached hereto; and (i) all renewals thereof, (ii) all income, royalties, damages and payments now or hereafter due or payable under or with respect to any of the foregoing, including, without limitation, damages and payments for past, present and future infringements of any of the foregoing, (iii) the right to sue for past, present and future infringements of any of the foregoing and (iv) the goodwill of Obligor's business symbolized by the foregoing and connected therewith (all of the foregoing in this subsection (a) are collectively referred to as the "Trademarks");

(b) Copyrights, including, without limitation, those listed on Exhibit B attached hereto, whether or not the underlying works of authorship have been published, all registrations and recordings thereof and all applications in connection therewith, and (i) all renewals thereof, (ii) all income, royalties, damages and payments now or hereafter due or payable under or with respect to any of the foregoing, including, without limitation, damages and payments for past, present and future infringements of any of the foregoing and (iii) the right to sue for past, present and future infringements of any of the foregoing (all of the foregoing in this subsection (b) are collectively referred to as the "Copyrights");

(c) Patents and patent applications, including, without limitation, the patents listed on Exhibit C attached hereto; and (i) all renewals thereof, (ii) all income, royalties, damages and payments now or hereafter due or payable under or with respect to any of the foregoing, including, without limitation, damages and payments for past, present and future infringements of any of the foregoing and (iii) the right to sue for past, present and future infringements of any of the foregoing (all of the foregoing in this subsection (c) are collectively referred to as the "Patents"); and

(d) Rights under and interests in all trademark license agreements, service mark license agreements (together with any goodwill connected with and symbolized by any such trademark license agreements or service mark license agreements) and patent license agreements with any other party, including, without limitation, those listed on Exhibit D attached hereto, whether Obligor is a licensee or licensor under any such license agreement, but excluding any license agreement if (and solely to the extent and for so long as) such license agreement expressly prohibits the Obligor from granting any Lien thereon (all of the foregoing in this subsection (d) are collectively referred to as the "Licenses").

2. Warranties and Representations. Obligor represents and warrants to the Lender that:

(a) None of the Pledged Collateral has been adjudged invalid or unenforceable by a court of competent jurisdiction nor has any such Pledged Collateral been cancelled in whole or in part and each such Trademark, Copyright, Patent and License is presently subsisting;

(b) The Obligor is the sole and exclusive owner of the entire and unencumbered right, title and interest in and to the Pledged Collateral, free and clear of any Liens (other than the Lien of the Senior Lender securing the Senior Bank Debt), charges and encumbrances, including without limitation, shop rights and covenants by Obligor not to sue third persons;

(c) The Obligor has no notice of any suits or actions commenced or, to the Obligor's knowledge, threatened with reference to the Pledged Collateral; and

(d) The Obligor has the unqualified right to execute and deliver this Agreement and perform in accordance with its terms.

3. Restrictions on Future Agreements. Until the Secured Liabilities are paid in full and the Loan Documents have been terminated, the Obligor will not, without the prior written consent of the Lender, sell, assign or license their interest in the Pledged Collateral or enter into any other agreement with respect to the Pledged Collateral which would affect the validity or enforcement of the rights transferred to the Lender under this Agreement.

4. New Trademarks, Patents and Licenses. Obligor represents and warrants to the Lender that the Trademarks listed on Exhibit A, the Copyrights listed on Exhibit B and the Patents listed on Exhibit C constitute all of the Trademarks, Copyrights and Patents now owned by the Obligor. If, before the Secured Liabilities are paid in full or before the Loan Documents have been terminated, Obligor (a) becomes aware of any existing Trademark, Copyright, Patents or License of which the Obligor has not previously informed the Lender or (ii) becomes entitled to the benefit of any Trademark, Copyright, Patents or License which benefit is not in existence on the date hereof, then the provisions of this Agreement will automatically apply thereto and the Obligor will give to Lender prompt written notice thereof. The Obligor hereby authorizes the Lender to modify this Agreement by amending the Exhibits hereto to include any such Trademark, Copyright, Patent or License and to file a duplicate original of this Agreement containing the amended Exhibits.

5. Term. The term of this Agreement will extend until the Secured Liabilities are paid in full and the Loan Documents have been terminated.

6. Release of Agreement. This Agreement is made for collateral purposes only. Upon payment in full of the Secured Liabilities and termination of the Loan Documents, the Lender shall promptly execute and deliver to Obligor, at Obligor's expense, all termination statements and other instruments as may be necessary or proper to terminate Lender's security interests created hereby and pursuant to the Loan Documents.

7. Expenses. All expenses incurred in connection with the performance of any of the agreements set forth herein will be borne by the Obligor. All fees, costs and expenses, of whatever kind or nature, including reasonable attorneys' fees and legal expenses, incurred by the Lender in connection with the filing or recording of any documents (including all taxes in connection therewith) in public offices, the payment or discharge of any taxes, reasonable counsel fees and expenses, maintenance fees, encumbrances or otherwise in protecting, maintaining or preserving the Pledged Collateral or in defending or prosecuting any actions or proceedings arising out of or related to the Pledged Collateral will be borne by and paid by the Obligor and until paid will constitute Secured Liabilities.

8. Duties of Obligor. The Obligor will (a) diligently file and prosecute all pending applications relating to the Pledged Collateral, (b) preserve and maintain all rights in the Pledged Collateral and (c) ensure that the Pledged Collateral is and remains enforceable provided, however, that the Obligor will not be required to preserve and maintain any Trademarks that the Obligor no longer finds useful in the conduct of its business in its reasonable business judgment.

9. Lender's Right to Sue. After the occurrence of an Event of Default and the continuance thereof, the Lender will have the right, but will in no way be obligated, to bring suit in its own name to enforce the Pledged Collateral and, if the Lender commences any such suit, the Obligor will, at the request of the Lender, do any and all lawful acts and execute any and all proper documents required by the Lender in aid of such enforcement and the Obligor will promptly, upon demand, reimburse and

indemnify the Lender for all documented costs and expenses incurred in the exercise of its rights under this Section 9, including, without limitation, reasonable attorney's fees and expenses.

10. **Waivers.** No course of dealing between the Obligor and the Lender, nor any failure to exercise, nor any delay in exercising, on the part of the Lender, any right, power or privilege hereunder or under the Loan Documents will operate as a waiver thereof; nor will any single or partial exercise of any right, power or privilege hereunder or thereunder preclude any other or further exercise thereof or the exercise of any other right, power or privilege.

11. **Modification.** No amendment, modification, termination, discharge or waiver of any provision of this Agreement or consent to any departure by the Obligor therefrom, shall in any event be effective, except as specifically provided in Section 4 hereof, unless the same shall be in writing and signed by the Lender, and then such waiver or consent shall be effective only for the specific purpose for which given.

12. **Cumulative Remedies; Power of Attorney; Effect on Loan Documents.** All of the Lender's rights and remedies with respect to the Pledged Collateral, whether established hereby, by the Loan Documents, by any other agreements or by law will be cumulative and may be exercised singularly or concurrently. The Obligor hereby irrevocably designates, constitutes and appoints the Lender (and authorizes the Lender to make, constitute and appoint any officer or agent of the Lender as the Lender may select in its sole discretion) as the Lender's true and lawful attorney-in-fact with power, upon the occurrence and during the continuance of an Event of Default, and subject to any applicable limitations or restrictions on the Obligor's rights in the Pledged Collateral to: (a) endorse the Obligor's name on all applications, documents, papers and instruments necessary or desirable for the Lender in the use of the Pledged Collateral; (b) take any other actions with respect to the Pledged Collateral as the Lender deems to be in its best interests; (c) grant or issue any exclusive or non-exclusive license under the Pledged Collateral to anyone on commercially reasonable terms; or (d) assign, pledge, convey or otherwise transfer title in or dispose of any Pledged Collateral to anyone on commercially reasonable terms. The Lender hereby ratifies all that such attorney will lawfully do or cause to be done by virtue hereof. This power of attorney will be irrevocable until the Secured Liabilities will have been paid in full and the Loan Documents have been terminated. The Obligor acknowledges and agrees that this Agreement is not intended to limit or restrict in any way the rights and remedies of the Lender under the Loan Documents but rather is intended to facilitate the exercise of such rights and remedies. The Lender will have, in addition to all other rights and remedies given it by the terms of this Agreement and the Loan Documents, all rights and remedies allowed by law and the rights and remedies of a secured party under the Uniform Commercial Code as enacted in Illinois, from time to time. THE OBLIGOR HEREBY AUTHORIZES THE LENDER TO FILE THIS AGREEMENT WITH THE UNITED STATES PATENT AND TRADEMARK OFFICE AND THE UNITED STATES COPYRIGHT OFFICE.

13. **Binding Effect; Benefits.** This Agreement will become effective upon execution by the Obligor and the Lender. If this Agreement is not dated or contains any blanks when executed by the Obligor, the Lender is hereby authorized, without notice to the Obligor, to date this Agreement as of the date when it was executed by the Obligor, and to complete any such blanks according to the terms upon which this Agreement is executed. This Agreement will be binding upon the Obligor and their respective successors and assigns, and will inure to the benefit of the Lender, their successors, nominees and assigns.

14. **Enforceability.** Wherever possible, each provision of this Agreement will be interpreted in such manner as to be effective and valid under applicable law, but if any provision of this Agreement shall be prohibited by, unenforceable or invalid under any jurisdiction, such provision will as to such jurisdiction, be severable and be ineffective to the extent of such prohibition or invalidity, without

invalidating the remaining provisions of this Agreement or affecting the validity or enforceability of such provision in any other jurisdiction.

15. Survival. All covenants, agreements, representations and warranties made by the Obligor herein will, notwithstanding any investigation by the Lender, be deemed material and relied upon by the Lender and shall survive the making and execution of this Agreement and the Loan Documents and the issuance of the Note, and shall be deemed to be continuing representations and warranties until such time as the Obligor has fulfilled all of their Secured Liabilities to the Lender, and the Lender has been paid in full. The Lender, in extending financial accommodations to the Obligor, is expressly acting and relying on the aforesaid representations and warranties.

16. Governing Law. This Agreement will be delivered and accepted in and will be deemed to be a contract made under and governed by the internal laws of the State of Illinois (but giving effect to federal laws applicable to national banks), and for all purposes will be construed in accordance with the laws of such State, without giving effect to the choice of law provisions of such State.

17. WAIVER OF JURY TRIAL. THE LENDER AND THE OBLIGOR, AFTER CONSULTING OR HAVING HAD THE OPPORTUNITY TO CONSULT WITH COUNSEL, EACH KNOWINGLY, VOLUNTARILY AND INTENTIONALLY WAIVES IRREVOCABLY, THE RIGHT TO TRIAL BY JURY WITH RESPECT TO ANY LEGAL PROCEEDING BASED HEREON, OR ARISING OUT OF, UNDER OR IN CONNECTION WITH THIS AGREEMENT, THE PLEDGED COLLATERAL, OR ANY OTHER AGREEMENT EXECUTED OR CONTEMPLATED TO BE EXECUTED IN CONJUNCTION WITH THIS AGREEMENT, OR ANY COURSE OF CONDUCT OR COURSE OF DEALING IN WHICH THE LENDER AND THE OBLIGOR ARE ADVERSE PARTIES. THIS PROVISION IS A MATERIAL INDUCEMENT FOR THE LENDER GRANTING ANY FINANCIAL ACCOMMODATION TO THE OBLIGOR.

18. LITIGATION. TO INDUCE THE LENDER TO MAKE THE LOAN, THE OBLIGOR IRREVOCABLY AGREES THAT ALL ACTIONS ARISING, DIRECTLY OR INDIRECTLY, AS A RESULT OR CONSEQUENCE OF THIS AGREEMENT, ANY OTHER AGREEMENT WITH THE LENDER OR THE PLEDGED COLLATERAL, SHALL BE INSTITUTED AND LITIGATED ONLY IN COURTS HAVING THEIR SITUS IN THE CITY OF CHICAGO, ILLINOIS. OBLIGOR HEREBY CONSENTS TO THE EXCLUSIVE JURISDICTION AND VENUE OF ANY STATE OR FEDERAL COURT HAVING ITS SITUS IN SAID CITY, AND WAIVES ANY OBJECTION BASED ON FORUM NON CONVENIENS. OBLIGOR HEREBY WAIVES PERSONAL SERVICE OF ANY AND ALL PROCESS AND CONSENTS THAT ALL SUCH SERVICE OF PROCESS MAY BE MADE BY CERTIFIED MAIL, RETURN RECEIPT REQUESTED, DIRECTED TO THE OBLIGOR TO THE ADDRESS SET FORTH IN THE LOAN AGREEMENT, IN THE MANNER PROVIDED BY APPLICABLE STATUTE, LAW, RULE OF COURT OR OTHERWISE.

19. Headings. Section headings used herein are for convenience only and will not modify the provisions which they precede.

20. Further Assurances. Obligor agrees to execute and deliver such further agreements, instruments and documents, and to perform such further acts, as the Lender will reasonably request from time to time in order to carry out the purpose of this Agreement and agreements set forth herein.

21. Counterparts. This Agreement may be executed in any number of counterparts and by different parties hereto in separate counterparts, each of which when so executed and delivered shall be deemed to be an original and all of which taken together shall constitute one and the same instrument.

22. Intercreditor Agreement.

(a) Notwithstanding any provision to the contrary in this Agreement, this Agreement, the Liens and security interests granted to the Lender, at law or equity, pursuant to this Agreement, and the exercise of any right or remedy by the Lender hereunder are subject to the provisions of the Intercreditor Agreement. Without limiting the generality of the foregoing, and notwithstanding anything herein to the contrary, all right and remedies of the Lender shall be subject to the applicable terms of the Intercreditor Agreement.

(b) Obligor acknowledges that the Intercreditor Agreement and the rights and benefits thereof (as specific references thereto herein) inure only to the benefit of the Senior Lender and that no other Person, including the Obligor, shall have or be entitled to assert any rights or benefits hereunder arising under the Intercreditor Agreement or by virtue of the existence of the specific references thereto herein.


