RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS, dated as of April 30, 2015 (this "Release"), is made by WELLS FARGO BANK, NATIONAL ASSOCIATION ("WFBNA"), a United States Banking Organization located at 7000 Central Parkway NE, Suite 550, Atlanta, Georgia 30328, in its capacity as collateral agent under the Indenture referenced below (in such capacity, "Agent"), in favor of EXIDE TECHNOLOGIES, a Delaware Corporation located at 13000 Deerfield Pkwy Bldg. 200, Milton, Georgia 30004 ("Grantor"). Capitalized terms used in this Release but not otherwise defined herein shall have the respective meanings ascribed to such terms in the Security Agreement, or, if not defined therein, in the Indenture.

WHEREAS, pursuant to that certain Indenture dated as of January 25, 2011 (as amended, restated, supplemented, or otherwise modified from time to time, the "Indenture") by and among the Grantor and WFBNA, as trustee (in such capacity, together with its successors and assigns, the "Trustee"), on behalf of the holders (the "Noteholders") of the Notes (as defined below), pursuant to which the Grantor issued \$675,000,000 aggregate principal amount of its 8⁵/₈% Senior Secured Notes due 2018 (and, together with any Additional Notes and Exchange Notes which may be issued from time to time under the Indenture, the "Notes"), which, in accordance with the terms of the Indenture, are guaranteed by the Grantor;

WHEREAS, the Secured Parties were willing to make the financial accommodations to the Borrowers as provided for in the Indenture, but only upon the condition, among others, that the Grantors shall have executed and delivered to Agent, for the benefit of the Secured Parties, that certain Security Agreement, dated as of January 25, 2011 (including all annexes, exhibits or schedules thereto, as from time to time amended, restated, supplemented or otherwise modified, the "Security Agreement"); and

WHEREAS, in accordance with the Security Agreement, Grantor and Agent entered into that certain Trademark Security Agreement, dated as of January 25, 2011 (the "Trademark Security Agreement"), pursuant to which Grantor unconditionally granted, assigned, and pledged to Agent, for the benefit of each Secured Party, to secure the Obligations, a continuing security interest into all of such Grantor's right, title and interest in and to the following, whether then owned or existing or thereafter created, acquired or arising (collectively, "Trademark Collateral"):

(i) all of its Trademarks and Trademark Intellectual Property Licenses to which it is a party including those referred to on Schedule A, except for any United States intent-to-use trademark applications to the extent that, and solely during the period in which, the grant of a security interest therein would impair the validity or enforceability of such intent-to-use trademark applications under applicable federal law, provided that upon submission and acceptance by the PTO of an amendment to allege use or statement of use pursuant to 15 U.S.C. Section 1060(a) (or any successor provision), such intent-to-use trademark application shall be considered Trademark Collateral;

(ii) all goodwill of the business connected with the use of, and symbolized by, each Trademark and each Trademark Intellectual Property License; and

(iii) all products and proceeds (as that term is defined in the Code) of the foregoing, including any claim by such Grantor against third parties for past, present or future (i) infringement or dilution of any Trademark or any Trademarks exclusively licensed under any Intellectual Property License, including right to receive any damages, (ii) injury to the goodwill associated with any Trademark, or (iii) right to receive license fees, royalties, and other compensation under any Trademark Intellectual Property License.

WHEREAS, the Trademark Security Agreement was recorded in the United States Patent and Trademark Office on January 25, 2011, at Reel 4460 / Frame 0264; and

WHEREAS, the Secured Obligations have been fully paid and performed and Agent has agreed to terminate the Trademark Security Agreement and release its security interest in all such Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. Release of Lien. Agent hereby terminates the Trademark Security Agreement and hereby terminates, cancels and releases any and all liens and security interests that it has in, to and under the Trademark Collateral.

2. Authorization to Record. Agent authorizes and requests that the United States Patent and Trademark Office and any applicable government officer record this Release.


3. Further Assurances. Agent shall take all further actions and provide to Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of documents or other instruments), reasonably requested by Grantor to more fully and effectively effectuate the purposes of this Release, at Grantor's sole expense, and without representation or warranty by Agent.

4. Governing Law. This Release is made under and governed by the laws of the State of New York applicable to contracts made and to be performed entirely within such State, without regard to conflicts of laws principles.
