

Record of probate proceedings

According to the Probate Court's enquiries to date the following persons come into question as legal heirs of the deceased person:

1. the widow Mrs. Gertrud Weihing, née Grünenwald, born on September 30, 1938, resident in Bahnhofstraße 77, 72127 Kusterdingen-Mähringen, 1/4
2. the son Jörg Weihing, born on February 07, 1966, resident in Rappenberghalde 90, 72070 Tübingen, 3/8
3. the son Robert Weihing, born on October 09, 1968, resident in Nauklerstraße 31, 72074 Tübingen, 3/8.

On the base of the marriage contract from October 4, 1969, the married couple Ewald and Gertrud Weihing lived according to the legal matrimonial property scheme of conjugal community.

The following dispositions mortis causa shall be opened:

- a contract of inheritance from October 4, 1969 established in connection with the above mentioned marriage contract, notarial register no. 101/1969, administrative record no. 2334;
- a joint notarial testament from December 12, 2005, document no. 846/2005-II of the Notary's Office Metzingen, which has been hitherto kept in official custody under custody book no. 100256 by the Notary's Office Metzingen, which was opened there on November 28, 2006 according to § 2261 BGB and was brought here afterwards.

Regarding the sealed condition of the testamentary dispositions to be opened, the following was noted:

The marriage and inheritance contract from October 04, 1969 is to be found open among the probate documents.

The joint notarial testament from December 12, 2005, opened by the Notary's Office Metzinger – Custody Court – on November 28, 2006 according to § 2261 BGB, is to be found open with the associated opening protocol.

The date of opening the same ones has been fixed for today, the above mentioned legal heirs have been summoned.

The dispositions with respect to the last will were completely opened with the agreement of Mrs. Weihing and presented to the persons who had appeared for review instead of being read aloud, according to § 2260, second sentence of clause 2 BGB.

The persons declare:

1. Other testamentary dispositions, in particular handwritten testaments, are not known. No handwritten testaments have been found. The obligation to deliver such testaments to the Probate Court is known.
2. The inheritance is accepted.

It is known that if the heirs declare the acceptance of the inheritance, it will be principally excluded to renounce it at a later time. This applies, in particular, in view of possible limitations and restrictions of the inheritance with respect to § 2306 BGB.

As mentioned on page 2 of the protocol, the legal heirs have been correctly and completely ascertained by the Probate Court. Other descendants of the testator (e.g. illegitimate descendants with respect to former legal systems) do not exist.

The Probate Court has still indicated:

- The forced heirship of descendants and its limitation period of 3 years.
- The possibility of an amendment of the Land Register which is free of charge according to § 60 clause 4 KostO (law of charges), as far as a certificate of inheritance according to § 35 GBO (Land Registration Act) exists.

The testator was a shareholder of the "Schrift und Bild Werbe GmbH" with registered office in Potsdam. There is no inheritance abroad.

No applications are made to the Probate Court. Other official activities apart from today's opening of the testamentary dispositions with notification of the persons involved according to § 2262 BGB are not required.
