**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”), dated as of May 12, 2015 (the “Effective Date”), is made by PNC Bank, National Association, in its capacity as administrative agent and collateral agent for the Secured Parties (the “Administrative Agent”), in favor of the grantor parties identified on the signature page hereto (the “Grantors”).

WHEREAS, pursuant to that certain Security Agreement, dated as of October 11, 2013 by and among the Administrative Agent, the Grantors and certain other parties thereto (as amended, amended and restated, or otherwise modified from time to time, the “Security Agreement”), the Grantors granted to the Administrative Agent, in its capacity as Administrative Agent for the benefit of the Secured Parties, a security interest in and to certain collateral;

WHEREAS, pursuant to the Security Agreement, the Grantor executed and delivered a Patent, Trademark and Copyright Security Agreement (the “Original Patent, Trademark and Copyright Security Agreement”), dated as of October 11, 2013, as supplemented by a Grant of Security Interest in Patents, Trademarks and Copyrights, (the “First Supplemental Trademark Security Agreement”), dated as of December 31, 2014, and a Grant of Security Interest in Patents, Trademarks and Copyrights (the “Second Supplemental Trademark Security Agreement” and, together with the Original Patent Trademark and Copyright Security Agreement and the First Supplemental Trademark Security Agreement, the “Patent, Trademark and Copyright Security Agreement”), dated as of February 3, 2015, for recordal with the United States Patent and Trademark Office;

WHEREAS, the Original Patent, Trademark and Copyright Security Agreement was recorded with the United States Patent and Trademark Office on October 25, 2013 at Reel/Frame 005146/0219, the First Supplemental Trademark Security Agreement was recorded with the United States Patent and Trademark Office on January 6, 2015 at Reel/Frame 005434/0987 and the Second Supplemental Trademark Security Agreement was recorded with the United States Patent and Trademark Office on February 4, 2015 at Reel/Frame 005452/0877; and

WHEREAS, pursuant to the Patent, Trademark and Copyright Security Agreement and to secure the full payment and performance of all Secured Obligations, each Pledgor granted, and conveyed a security interest to the Administrative Agent for the benefit of the Secured Parties in the entire right, title and interest of such Pledgor in and to all of its future right, title and interest in and to the following, wherever located:

- a) all trademarks (including service marks), slogans, logos, certification marks, trade dress, uniform resource locators (URL’s), domain names, corporate names and trade names, whether registered or unregistered, owned by or assigned to such Pledgor and all registrations and applications for the foregoing (whether statutory or common law and whether established or registered in the United States or any other country or any political subdivision thereof) together with any and all (i) rights and privileges arising under applicable law with respect to such Pledgor’s use of any trademarks, (ii) reissues, continuations, extensions and renewals thereof and amendments thereto, (iii) income, fees, royalties, damages and payments then and thereafter due and/or payable thereunder and with respect thereto, including damages, claims and payments for past, present or future infringements thereof, (iv) rights corresponding thereto throughout the world, (v) rights to sue for past, present and future infringements thereof, (vi) all proceeds of the foregoing (such as, by way of example license royalties and proceeds of infringement suits) and (vii) the goodwill of the business to which any of the foregoing relates (“Trademarks”);

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby agrees as follows:

1. Defined Terms. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Security Agreement or the Patent, Trademark and Copyright Security Agreement, as applicable.

2. Release. The Administrative Agent, without representation or warranty of any kind, hereby releases, discharges, terminates and cancels all of its security interest in and to the Trademarks, including the trademark registrations and applications set forth Schedule I attached hereto, arising under the Security Agreement and the Patent, Trademark and Copyright Security Agreement. If and to the extent that the Administrative Agent has acquired any right, title or interest in and to the Trademarks under the Patent, Trademark and Copyright Security Agreement, the Administrative Agent, without representation or warranty of any kind, hereby re-transfers, re-conveys and re-assigns such right, title or interest to the Grantors.

3. Termination. The Administrative Agent, without representation or warranty of any kind, terminates and cancels the Patent, Trademark and Copyright Security Agreement.


4. Further Assurances. The Administrative Agent agrees to take all further actions, and provide to the Grantors and their respective successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantors, at the Grantors' sole cost and expense, to more fully and effectively effectuate the purposes of this Release.

5. Governing Law. This Release shall be governed exclusively under the laws of New York, without regard to conflicts of law or choice of law principles.


