**RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT**

May 21, 2015

WHEREAS, LUXOLOGY LLC, a California limited liability company (now known as THE FOUNDRY GROUP LLC, a California limited liability company) (the "Grantor"), granted a security interest in favor of SILICON VALLEY BANK, as Lender (in such capacity, "SVB"), and a lien upon certain trademark and trademark applications pursuant to that certain Intellectual Property Security Agreement dated September 17, 2012 by Grantor in favor of SVB, notice of which was recorded in the United States Patent and Trademark Office on September 20, 2012 at Reel 004864, Frame 0899 ("*Trademark Security Agreement*");

WHEREAS, Grantor has requested and SVB has agreed to release and reassign to Grantor its interest in all of Grantor's trademarks and trademark applications including the trademarks and trademark applications identified in Exhibit A hereto and made a part hereof; and

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, SVB hereby:

1. terminates the Trademark Security Agreement and releases, terminates and discharges all liens and security interests in all of Grantor's right, title and interest in, to and under the Trademarks (as defined in the Trademark Security Agreement) including those trademarks and trademark applications identified in Exhibit A and/or any goodwill associated with any of the trademarks identified in Exhibit A, without recourse or representation or warranty, express or implied of any kind;
2. authorizes and requests that the Commissioner for Trademarks at the United States Patent and Trademark Office note and record the existence of the release hereby given; and
3. agrees that it shall, at the Grantor's sole cost and expense and at any of the Grantor's, or their successor's or assign's, reasonable request, execute, acknowledge and deliver to the Grantor all further releases and other documents, and take all other actions necessary or reasonably desirable for the release of such security interest.
