TRADEMARK ASSIGNMENT

WHEREAS, pursuant to the terms and conditions of, the Purchase Agreement, ASSIGNOR has agreed to assign to ASSIGNEE all of its rights, title, and interest in, under, and to Trademarks, together with the goodwill of the business pertaining thereto;


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. ASSIGNOR hereby assigns unto ASSIGNEE all of ASSIGNOR’s right, title and interest in, under, and to the Trademarks, together with the goodwill of the business pertaining thereto and the right to bring suit and recover damages for past, present, and future infringement, dilution, misappropriation, violation, or unlawful imitation thereof, and all rights of priority and protection of interests therein under the laws of any jurisdiction in which such rights are protected.
2. ASSIGNOR hereby agrees to execute any additional documents reasonably requested by ASSIGNEE to accomplish and record this Assignment.
3. This Assignment shall be binding upon the parties and their successors and assigns.
4. This Assignment may be executed in counterparts, each of which shall be deemed an original and all of which, when taken together, shall constitute one and the same instrument.
5. This Assignment may be executed by facsimile or .pdf signature and a facsimile or .pdf signature shall constitute an original for all purposes.


