RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS

This Release of Security Interest in Trademark Rights (this “Release”) is made as of May 29, 2015, and granted by GOLDMAN SACHS BANK USA (the “Collateral Agent”), in its capacity as collateral agent pursuant to that certain Pledge and Security Agreement dated as of August 1, 2012 (as amended, restated, supplemented or otherwise modified from time to time, the “Pledge and Security Agreement”) by and among HOLOGIC, INC., a Delaware corporation (the “Borrower”), certain other subsidiaries of the Borrower (collectively, the “Grantor”) and the Collateral Agent. Capitalized terms used herein have the meanings attributed thereto in the Pledge and Security Agreement unless otherwise defined herein.

WHEREAS, pursuant to the Pledge and Security Agreement, a security interest (the “Security Interest”) was granted by the Grantor to the Collateral Agent in certain collateral, including the Trademark Collateral (as defined in the Trademark Security Agreement);

WHEREAS, pursuant to the terms and conditions of that certain Trademark Security Agreement, dated as of August 1, 2012 (the “Trademark Security Agreement”), between the Borrower, CYTYC CORPORATION, BIOLUCENT, LLC, INTERLACE MEDICAL, INC., SUROS SURGICAL SYSTEMS, INC., THIRD WAVE TECHNOLOGIES, INC., GEN-PROBE INCORPORATED, GEN-PROBE TRANSPLANT DIAGNOSTICS, INC., GEN-PROBE GTI DIAGNOSTICS, INC., GEN-PROBE PRODESSE, INC. and the Collateral Agent, which was recorded with the United States Patent and Trademark Office on August 1, 2012 on Reel 4833 Frame 0235, as supplemented from time to time including, without limitation, by that certain supplement which was recorded with the United States Patent and Trademark Office on January 11, 2013 on Reel 4941 Frame 0398, that certain supplement which was recorded with the United States Patent and Trademark Office on July 9, 2013 on Reel 5065 Frame 0549, that certain supplement which was recorded with the United States Patent and Trademark Office on April 25, 2014 on Reel 5268 Frame 0033, that certain supplement which was recorded with the United States Patent and Trademark Office on August 5, 2014 on Reel 5337 Frame 0033, that certain supplement which was recorded with the United States Patent and Trademark Office on January 22, 2015 on Reel 5445 Frame 0039, and that certain supplement which was recorded with the United States Patent and Trademark Office on May 11, 2015 on Reel 5513 Frame 0348, the Grantor pledged to the Collateral Agent, for the benefit of the Secured Parties, a Security Interest in and continuing lien on all of such Grantor’s right, title and interest in, to and under the Trademark Collateral; and

WHEREAS, the Collateral Agent now desires to terminate and release the entirety of its Security Interest in and lien on the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration including the satisfaction of all obligations, indebtedness and liabilities secured by the Trademark Collateral pursuant to the Pledge and Security Agreement, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Release, the Collateral Agent hereby states as follows:

1. **Definitions.** The term “Trademark Collateral” shall have the meaning provided by reference in the Trademark Security Agreement, and shall include, without limitation, all of the Grantor’s right, title and interest of every kind and nature as of the date hereof in the Trademarks listed on Schedule I hereto.
2. **Release of Security Interest.** The Collateral Agent hereby terminates the Trademark Security Agreement and hereby terminates, cancels, discharges and releases its Security Interest in and any lien upon the Trademark Collateral, in each case without warranty or recourse. If and to the extent


the Collateral Agent has acquired any right, title or interest in, to or under any of the Trademarks, then the Collateral Agent hereby assigns, transfers, conveys and delivers such right, title or interest to the Grantor.

3. Further Assurances. The Collateral Agent shall take all further actions, and provide to the Grantor and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantor to more fully and effectively effectuate the purposes of this Release, in each case at the Grantor's sole expense.

4. Governing Law. This Release shall be construed in accordance with and governed by the law of the State of New York.

IN WITNESS WHEREOF, the Collateral Agent has caused this Release to be executed and delivered by its duly authorized officer as of the date first set forth above.




