WHEREAS, BATTERIES PLUS, LLC, a Wisconsin limited liability company ("Grantor") and Agent were parties to (i) that certain Guarantor Security Agreement dated as of November 2, 2007 (the "GSA"), (ii) that certain Trademark Security Agreement dated as of August 29, 2014 (the "2014 TSA"), (iii) that certain Trademark Security Agreement dated as of December 19, 2013 (the "2013 TSA"), (iv) that certain Trademark Security Agreement dated as of December 20, 2012 (the "2012 TSA"), (v) that certain Trademark Security Agreement dated as of October 17, 2011 (the "2011 TSA"), (vi) the certain Trademark Security Agreement dated as of September 2, 2010 (the "2010 TSA"), and (vii) that certain Trademark Security Agreement dated as of November 2, 2007 (the "2007 TSA", and together with the GSA, the 2014 TSA, the 2013 TSA, the 2012 TSA, the 2011 TSA, and the 2010 TSA collectively, the "Security Agreements"), pursuant to which Grantor granted a security interest to Agent in certain Trademark Collateral as security for certain obligations owing by Grantor to Agent, including the Trademark Collateral set forth on Schedule I hereto;

- (a) all of its Trademarks, providing for the grant by or to the Grantor of any right under any Trademark, including, without limitation, those referred to on <u>Schedule 1</u> hereto;
 - (b) all renewals and extensions of the foregoing;

- (c) all goodwill of the business connected with the use of, and symbolized by, each such Trademark; and
- (d) all income, royalties, proceeds and Liabilities at any time due or payable or asserted under and with respect to any of the foregoing, including, without limitation, all rights to sue and recover at law or in equity for any past, present and future infringement, misappropriation, dilution, violation or other impairment thereof.
- 2. Agent hereby reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by Agent, any and all of Agent's right, title and interest in, to and under the Trademark Collateral.
- 3. The Agent hereby authorizes Grantor or Grantor's authorized representative to (i) record this Trademark Release and Reassignment with the U.S. Patent and Trademark Office and/or (ii) otherwise record or file this Trademark Release and Reassignment in the applicable governmental office or agency.
