TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS (the "Release") dated as of May 14, 2015, from BMO HARRIS BANK, N.A., a national banking association, (the "Grantee") to BELL AUTOMOTIVE PRODUCTS, INC., a Delaware corporation (the "Grantor")

WITNESSETH:

WHEREAS, Grantor executed in favor of Grantee (i) that certain TRADEMARK COLLATERAL AGREEMENT dated as of December 3, 2014 and recorded in the United States Patent and Trademark Office on December 26, 2014 at Reel 5429 Frame 0733, (ii) that certain TRADEMARK COLLATERAL AGREEMENT dated December 3, 2004 and recorded in the United States Patent and Trademark Office on February 4, 2005 at Reel 3024 Frame 0723, and (iii) that certain TRADEMARK COLLATERAL AGREEMENT dated October 28, 2005 and recorded in the United States Patent and Trademark Office on November 1, 2005 at Reel 3185 Frame 0001 and on December 2, 2005 at Reel 3203 Frame 0049 (collectively the "Security Agreements");

WHEREAS, pursuant to the Security Agreements, a security interest (the "Security Interest") was granted in certain Trademark Collateral as defined in the Security Agreements, including without limitation, the trademarks, trademark registrations and trademark applications listed on Schedule I attached hereto, (collectively, the "Collateral");

WHEREAS, the Grantee now desires to terminate and release the entirety of its Security Interest in the Collateral;

NOW, THEREFORE, for good and valuable consideration including the satisfaction of all obligations, indebtedness and liabilities secured by the Collateral pursuant to the Security Agreements, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Grantee hereby states as follows:

1. The Grantee hereby terminates, releases and discharges the Security Interest in and any and all claims against the Collateral, and any right, title or interest of the Grantee in such Collateral shall hereby cease and become void.

2. The Grantee hereby authorizes and directs the Commissioner of the United States Patent and Trademark Office, the United States Copyright Office and any other applicable government officials to record this Release.


3. At the request and reasonable expense of Grantors, the Grantee hereby agrees to execute, acknowledge and deliver all such further instruments and to take all such further actions necessary to carry out the purposes of this Release.

4. This Release and any claim, controversy, dispute or cause of action (whether in contract or tort or otherwise) based upon, arising out of or relating to this Release and the transactions contemplated hereby and thereby shall be governed by, and construed in accordance with, the laws the State of Illinois.
