TRADEMARK ASSIGNMENT

This Trademark Assignment (this "Assignment"), dated as of May 1, 2015, is by and between Caché, Inc., Caché of Las Vegas, Inc. and Caché of Virginia, Inc., as debtors and debtors in possession, ("Assignors") and The Cato Corporation ("Assignee").

RECITALS:

WHEREAS, Assignors are the record owners of the trademarks (whether registered, unregistered or pending), trade dress, service marks, service names, trade names, brand names, product names, logos, domain names, internet rights (including, without limitation IP Addresses and AS numbers), corporate names, fictitious names, other names, symbols (including business symbols), slogans, translations of any of any of the foregoing and any foreign or international equivalent of any of the foregoing and all goodwill associated therewith and (to the extent transferable by law) any applications and/or registrations in connection with the foregoing and all advertising and marketing collateral including any of the foregoing listed in Attachment 1 (the "Marks"), attached hereto and incorporated herein;

WHEREAS, Assignors' Chapter 11 bankruptcy cases are being jointly administered as In re Caché, Inc., et al., Case No. 15-10172 (MFW) before the United States Bankruptcy Court for the District of Delaware (the "Bankruptcy Court");

WHEREAS, Assignors entered into that certain Agency Agreement, dated March 4, 2015 (the "Agency Agreement"), with Great American Group WF, LLC ("Agent"), which Agency Agreement was approved by the Bankruptcy Court pursuant to the *Order Approving Sale of All or Substantially All of Debtors' Assets and Granting Related Relief* [Docket No. 275] entered on March 6, 2014 (the "Agency Order");

WHEREAS, pursuant to the terms and conditions of the Agency Agreement and for valuable consideration paid to Assignors, Agent was granted the right to designate the ultimate purchaser of certain assets of Assignors, including the Marks;

WHEREAS, pursuant to the terms and conditions of the Agency Agreement, Agent has designated Assignee as the purchaser and assignee of the Marks;

WHEREAS, subject to the approval of the Bankruptcy Court, Assignor desires to sell, assign, convey, and transfer all of its right, title and interest in and to the Marks on the terms and conditions herein;

WHEREAS, pursuant to that certain *Order Authorizing and Approving the Sale of Certain Intellectual Property Assets and Customer Lists* [Docket No. 508] entered on April 28, 2015 (the "Sale Order"), the Bankruptcy Court has approved the assignment of the Marks to Assignee; and

WHEREAS, Assignee desires to accept such assignment, conveyance, and transfer on the conditions set forth in the Sale Order and herein.

NOW, THEREFORE, in consideration of the foregoing recitals, the mutual covenants and agreements set forth herein and other good and valuable consideration, the sufficiency of which is hereby acknowledged by each of the parties hereto, the parties agree as follows:

1. Assignment. Assignors hereby assign, transfer and convey to Assignee all of Assignors' respective right, title and interest in and to the Marks, together with (a) the goodwill of the business symbolized by the Marks, (b) any and all common law rights, title and interest associated with the Marks, and (c) all causes of action, claims and demands and other rights for, or arising from, any infringement, including past infringements, of the Marks.
2. Consideration. For the Marks, Agent has provided Assignors consideration provided for in the Agency Agreement.
3. Certain Disclaimers. Subject to the terms of the Agency Order, Sale Order and Agency Agreement, Assignors make no representations or warranties, express or implied, respecting the Marks, including without limitation, merchantability or fitness of the Marks or any other portion thereof for any particular purpose or use. Assignors hereby disclaim any warranty (express or implied) of merchantability or fitness for any particular purpose as to any portion of the Marks. Accordingly, Assignee hereby accepts the Marks "AS IS" and "WHERE IS."
4. Further Assurances. At the request and expense of Assignee or its counsel, Assignors shall make, execute and deliver such additional assignment documents, certificates and other confirmatory instruments as may be necessary to give full effect to this Assignment and to permit Assignee to be duly recorded as the legal and registered owner of the Marks and all of the rights hereby conveyed; provided, however, that nothing herein shall be deemed to require Assignors to: (a) execute or deliver any such further assurance, document or instrument or take any action (i) to the extent that the same could in any material way increase the burdens, obligations or liabilities otherwise imposed upon Assignors by the Agency Agreement, or (ii) that would entail any cost or expense to be incurred by Assignors; or (b) initiate or join in any litigation or other proceeding.
5. Transfer Fees. Assignee shall be responsible for and bear and timely pay to the appropriate governmental authority any applicable sales, purchase, transfer, stamp, use or similar taxes under the laws of the state(s) applicable to the transfers provided herein, or any subdivision of any such state(s), which are or will be payable by reason of the transaction contemplated herein.




