**TRADEMARK RELEASE AND REASSIGNMENT**

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of May 29, 2015, by **ANTARES CAPITAL CORPORATION**, as Administrative Agent ("**Antares**").

WITNESSETH:

WHEREAS, Antares and Woodstream Corporation, a Pennsylvania corporation ("**Grantor**"), were parties to that certain Trademark Security Agreement, dated as of April 1, 2010 (the "**Assignment**"), pursuant to which Grantor granted a security interest to Antares in certain trademarks (the "**Trademarks**") and Trademark Rights (as defined below) as security for certain obligations owing by Grantor to Antares, including the Trademarks set forth on Schedule 1 hereto; and

WHEREAS, the Assignment was recorded by the Trademark Division of the United States Patent and Trademark Office on April 1, 2010, at Reel 4178, Frame 0572; and

WHEREAS, Grantor has requested that Antares release its security interest in the Trademarks and Trademark Rights and reassign the same to Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Antares hereby releases its security interest in all of Grantor's right, title and interest in and to the following (collectively the "**Trademark Rights**"):

a. all of its Trademarks and all IP Licenses providing for the grant by or to such Grantor of any right under any Trademark, including, without limitation, those referred to on Schedule 1 hereto;

b. all renewals and extensions of the foregoing;

c. all goodwill of the business connected with the use of, and symbolized by, each such Trademark; and


d. all income, royalties, proceeds and Liabilities at any time due or payable or asserted under and with respect to any of the foregoing, including, without limitation, all rights to sue and recover at law or in equity for any past, present and future infringement, misappropriation, dilution, violation or other impairment thereof.

2. Antares hereby reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by Antares, all of Antares' right, title and interest in and to the Trademarks and the Trademark Rights.
