AMENDED AND RESTATED TRADEMARK SECURITY AGREEMENT

AMENDED AND RESTATED TRADEMARK SECURITY AGREEMENT, dated as of June 12, 2015, by each of the undersigned (each a "Grantor" and collectively the "Grantors"), in favor of MADISON CAPITAL FUNDING LLC, in its capacity as agent ("Agent") for Lenders (as hereinafter defined).

W I T N E S S E T H:

WHEREAS, pursuant to that certain Credit Agreement dated as of August 15, 2014 by and among certain of the Grantors, certain affiliates of the Grantors, Agent and the lenders ("Lenders") from time to time party thereto (including all annexes, exhibits or schedules thereto, as from time to time amended, restated, supplemented or otherwise modified, the "Existing Credit Agreement"), Agent and Lenders agreed to make Loans and to issue Letters of Credit for the benefit of the Borrowers (as defined in the Credit Agreement).

WHEREAS, certain of the Grantors previously executed and delivered to Agent, for itself and the ratable benefit of the Lenders and (to the extent provided therein) their Affiliates (a) that certain Guarantee and Collateral Agreement dated as of August 15, 2014 (including all annexes, exhibits or schedules thereto, as from time to time amended, restated, supplemented or otherwise modified, the "Original Collateral Agreement"), (b) that certain Trademark Security Agreement dated as of August 15, 2014 between certain of the Grantors and Agent (including all annexes, exhibits or schedules thereto, as from time to time amended, restated, supplemented or otherwise modified, the "Original Trademark Security Agreement") and (c) that certain Trademark Security Agreement dated as of January 16, 2015, by Five Star Painting, Inc. in favor of Agent (including all annexes, exhibits or schedules thereto, as from time to time amended, restated, supplemented or otherwise modified, the "Five Star Trademark Security Agreement" and, together with the Original Trademark Security Agreement, collectively the "Original Trademark Security Agreements");

WHEREAS, certain of the Grantors, certain affiliates of the Grantors, Agent and the Lenders concurrently are entering into that certain Amended and Restated Credit Agreement dated as of event date herewith (including all annexes, exhibits or schedules thereto, as from time to time further amended, restated, supplemented or otherwise modified, the "Credit Agreement");

WHEREAS, Agent and Lenders are willing to amend and restate the Existing Credit Agreement and are willing to make the Loans and to issue Letters of Credit as provided for in the Credit Agreement, but only upon the condition, among others, that the Grantors shall have agreed to amend and restate the Original Collateral Agreement and pursuant thereto shall have executed and delivered to Agent, for itself and the ratable benefit of Lenders and (to the extent provided therein) their Affiliates, that certain Amended and Restated Guarantee and Collateral Agreement dated as of even date herewith (including all annexes, exhibits or schedules thereto, as from time to time further amended, restated, supplemented or otherwise modified, the "Collateral Agreement"); and

WHEREAS, as a condition to Agent and Lenders entering into the Credit Agreement, and pursuant to the Collateral Agreement, Grantors have agreed to amend and restate the Original Trademark Security Agreements as set forth herein;

NOW, THEREFORE, in consideration of the premises and mutual covenants herein contained and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, each Grantor hereby agrees as follows:

1. DEFINED TERMS. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Collateral Agreement.

2. GRANT OF SECURITY INTEREST IN TRADEMARK COLLATERAL. Each Grantor hereby grants to Agent, for its benefit and for the ratable benefit of Lenders and (to the extent provided in the Collateral Agreement) their Affiliates, a continuing security interest in all of such Grantor's right, title and interest in, to and under the following, whether presently existing or hereafter created or acquired (excluding any Excluded Assets, collectively, the "Trademark Collateral"):

- (a) all of its registered Trademarks set forth on Schedule I hereto;
- (b) all reissues, continuations or extensions of the foregoing;
- (c) subject to the Collateral Agreement, all goodwill of the business connected with the use of, and symbolized by, each Trademark; and
- (d) subject to the Collateral Agreement, all proceeds of the foregoing, including, without limitation, any claim by such Grantor against third parties for past, present or future (i) infringement or dilution of any Trademark or (ii) injury to the goodwill associated with any Trademark.

3. COLLATERAL AGREEMENT. The security interests granted pursuant to this Amended and Restated Trademark Security Agreement are granted in conjunction with the security interests granted to Agent, on behalf of itself and Lenders and (to the extent provided in the Collateral Agreement) their Affiliates, pursuant to the Collateral Agreement. Each Grantor hereby acknowledges and affirms that the rights and remedies of Agent with respect to the security interest in the Trademark Collateral made and granted hereby are more fully set forth in the Collateral Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein. In the event of any inconsistency, ambiguity or conflict between this Amended and Restated Trademark Security Agreement and the Collateral Agreement, the terms of the Collateral Agreement shall control.

4. RELEASE OF LIENS. Upon the occurrence of an event pursuant to the Credit Agreement or Collateral Agreement that would result in the release of all or a portion of the Trademark Collateral from the security interest thereon, the security interests granted herein shall automatically terminate, as applicable, with respect to all or such applicable portion of the Trademark Collateral. Upon any such release, Agent will, and at the Grantors' sole expense, release all or such applicable portion of the Trademark Collateral held by Agent hereunder, and execute and deliver to the applicable Grantor termination statements or such other documents as such Grantor shall reasonably request to evidence such termination, all without representation or warranty by Agent.

5. GOVERNING LAW. This Amended and Restated Trademark Security Agreement is made under and governed by the laws of the State of New York applicable to contracts made and to be performed entirely within such State, without regard to conflicts of laws principles.
