## DEED OF ASSIGNMENT

This DEED OF ASSIGNMENT is made the 30<sup>th</sup> day of April, 2015

BETWEEN

Koninklijke Philips N.V., a company incorporated in The Netherlands, having its registered office at High Tech Campus 5, 5656 AE Eindhoven, The Netherlands ("Assignor") on the one part,

and

Home Control Singapore Pte. Ltd., a company incorporated in Singapore, having its registered office at 620A Lorong 1, Toa Payoh, Singapore 319762 ("Assignee") on the other part.

This Deed of Assignment is to confirm the following:

Assignor is the registered owner of the Intellectual property rights listed in the Annexes to this Deed of Assignment (the "Assigned IPRs");

In consideration of a sum equivalent to at least one US\$ 1.00 (one US Dollar) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor has, effective as of the date of this Deed of Assignment, assigned to Assignee

all right, title and interest in and to

- the Business Patents as listed in Annex A-1,
- the Trademarks as listed in Annex C,
- the Designs as listed in Annex D,
- the Domain Names as listed in Annex E,

and

- a 50% interest in the Joint Patents as listed in Annex A-4,

subject to:

- (i) Assignor and its Affiliates retaining a world-wide, royalty-free, non-exclusive, unrestricted and irrevocable license under the Business Patents, Joint Patents, the RCB and RCB IPR (logo) Trademarks, and the Designs for the lifetime of these Assigned IPRs, to use these Assigned IPRs for and in any and all activities and applications that it or its Affiliates see fit, including the right to manufacture, use, import, offer to sell, sell or otherwise dispose of any product (including software), process or service including the right to have any such product, process or service made for it and/or its Affiliates or sold or otherwise disposed of for it or its Affiliates by third parties; and
- (ii) all prior commitments and prior undertakings vis-à-vis third parties entered into by Assignor or its Affiliates;

and Assignee has accepted said assignment.


When used in this Deed of Assignment, "Affiliate" shall mean any legal entity (i) owned or controlled by Assignor (ii) owning or controlling Assignor, or (iii) owned or controlled by the entity owning or controlling Assignor, either at of the date of this Deed of Assignment or at any time thereafter. For the purpose of this definition, an entity shall be deemed to own or control another entity if more than 50% (fifty per cent) of the stock of the latter entity, ordinarily entitled to vote in the election of directors (or, if there is no such stock, more than 50% (fifty per cent) of the ownership of or control in the latter entity) is directly or indirectly held by the owning or controlling entity.

Assignor hereby grants full power of attorney to Assignee to submit this Deed of Assignment, including the Annexes, to the authorities where the Assigned IPRs are registered, and to request those authorities to record the assignment from Assignor to Assignee in the appropriate registers provided that, where possible, the retained license to Assignor and its Affiliates shall be simultaneously recorded in those registers.


