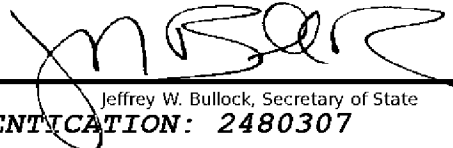

The name of this corporation (the "**Corporation**") is: OPTIV SECURITY INC."


**FIFTH:** The merger is to become effective on JULY 1, 2015.
