**THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of July 7, 2015, by **The Bank of New York Mellon**, in its capacity as administrative agent (the "Administrative Agent") in connection with that certain Security Agreement (Trademarks), dated as of May 14, 2008 (as may have been amended, restated, amended and restated, supplemented or otherwise modified from time to time, and as assigned to the Administrative Agent by that certain Assignment of Security Agreement (Trademarks), dated as of May 11, 2012, by Cuisine Innovations, LLC as Grantor (the "Grantor"), Harbinger Capital Partners Master Fund I, LTD. as resigning Administrative Agent and The Bank of New York Mellon as successor Administrative Agent, the "Trademark Agreement"), by the Grantor in favor of the Administrative Agent and the Grantor.

**WHEREAS**, pursuant to the terms of the Trademark Agreement, the Grantor granted to the Administrative Agent a security interest in the intellectual property identified on Exhibit A attached hereto (the "Trademarks");

**WHEREAS**, the Administrative Agent has agreed to terminate and release its security interest in the Trademarks as herein provided;


**WHEREAS**, the Trademark Agreement was recorded in the United States Patent and Trademark Office at Reel/Frame 003802/0175 on June 24, 2008;

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby terminates, releases and discharges, without recourse, representation or warranty, all of the Administrative Agent's security interest in the Trademarks of the Grantor, including, without limitation, the trademarks listed on Exhibit A attached hereto, effective as of the date set forth above.

The Administrative Agent hereby acknowledges that this document may be filed along with any other necessary documentation with the United States Patent and Trademark Office, to evidence the termination and release granted herein. The Administrative Agent hereby agrees to deliver any further releases or termination statements as may be reasonably necessary to effect the termination and release contemplated hereby, at the Grantor's expense.
