RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF TRADEMARK SECURITY INTEREST ("Release") is made and effective as of July 14th, 2015 and granted by SILICON VALLEY BANK, as the bank ("Bank"), under the Security Agreement referred to below, in favor of QUANTIA, INC., a Delaware Corporation, with its principal place of business at 200 West Street, Waltham, Massachusetts 02451 ("Grantor").

WHEREAS, Bank and Grantor entered into a Trademark Security Agreement, dated as of November 12, 2014 (the "Security Agreement"), which was recorded in the United States Patent and Trademark Office on November 13, 2014, at Reel 5400, Frame 0416, pursuant to which Grantor granted to Bank, by way of a first mortgage and security interest, a security interest having priority over all other security interests, to all of Grantor's right, title and interest in and to the Trademarks (as defined in the Security Agreement) referred to in Schedule A thereto, and identified in Schedule A to this RELEASE, and all good will associated with the Trademarks and Licenses; and,

WHEREAS, Grantor has promptly paid and performed all its Secured Obligations (as defined in the Security Agreement), and Bank desires to release its security interests in and liens upon the Trademark rights and Licenses.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Bank hereby releases its lien on and security interest in all Grantor's right, title and interest in and to the Trademarks and Licenses and reassigns any and all interest it may have in such Trademarks and Licenses to Grantor.
