ASSIGNMENT OF TRADEMARKS

This ASSIGNMENT OF TRADEMARKS (the “Assignment”) is made as of June 19, 2015 (the “Effective Date”), by and among RadioShack Corporation, a Delaware corporation (“RadioShack”), and TRS Quality Inc., a Subsidiary of RadioShack (together with RadioShack, “Assignors” and each individually, an “Assignor”), General Wireless IP Holdings LLC, a Delaware limited liability company (“GW IP” or “Assignee”), and General Wireless Operations Inc., a Delaware corporation (“GWO”).

WHEREAS, GWO and RadioShack and its Subsidiaries have entered into that certain Purchase Agreement, dated as of May 15, 2015 (as amended or amended and restated from time to time, the “Purchase Agreement”), pursuant to which each Assignor agreed to sell, transfer, assign, convey and deliver, or cause to be sold, transferred, assigned, conveyed and delivered, to GWO, and GWO agreed to purchase, all of such Assignor’s right, title and interest in, to or under the Purchased Assets, which includes the Assigned Marks;

WHEREAS, Assignor has adopted, used and is using the marks set forth on Schedule I hereto and incorporated by reference herein, which are registered in, or for which application for registration has been filed in, the United States Patent and Trademark Office (collectively, the “Assigned Marks”);

WHEREAS, Assignee desires to purchase or acquire Assignor’s right, title and interest in and to the Assigned Marks; and

WHEREAS, this Assignment is being entered into in connection with the Closing,

NOW, THEREFORE, for good and valuable consideration, including the premises and covenants set forth in the Purchase Agreement, the receipt and sufficiency of which are hereby acknowledged, each Assignor and Assignee agree as follows:

Each Assignor does hereby sell, transfer, assign, convey and deliver to Assignee all right, title and interest of such Assignor in and to the Assigned Marks, the registrations and applications for registrations thereof, and the goodwill of the business connected with the use thereof and symbolized thereby, free and clear of all Liens (other than as set forth in the Purchase Agreement); all rights of priority therein in any country as may now or hereafter be granted to it by law, treaty or other international convention; and all rights, interests, claims and demands recoverable in law or equity, that Assignor has or may have in profits and damages for past, present and future infringements of the Assigned Marks, including, without limitation, the right to compromise, sue for and collect such profits and damages; the same to be held and enjoyed by Assignee, its successors and assigns or their legal representatives, as fully and entirely as the same would have been held and enjoyed by Assignor if this Assignment had not been made.

Each Assignor, GWO and GW IP hereby agree to execute such other documents and perform such further acts as may be reasonably required or advisable to carry out the provisions hereof and the transactions contemplated hereby.

Nothing in this Assignment, express or implied, is intended to or shall be construed to modify, expand, supersede or limit in any way the terms, conditions or obligations set forth in the Purchase Agreement. To the extent that any provision of this Assignment conflicts or is inconsistent with the terms of the Purchase Agreement, the Purchase Agreement shall control and govern. Capitalized terms not otherwise defined herein have their respective meanings set forth in the Purchase Agreement.

Except to the extent the mandatory provisions of the Bankruptcy Code apply, and except as to trademark issues, which shall be governed by the laws of the United States, this Assignment and all transfers of property and other actions confirmed hereby shall be governed, construed and interpreted in accordance with the terms and conditions of the Purchase Agreement and the laws of the State of Delaware applicable to Contracts made and to be performed entirely in such state without regard to principles of conflicts or choice of laws or any other law that would make the laws of any other jurisdiction other than the State of Delaware applicable hereto.



This Assignment may be executed in counterparts, each of which shall be deemed to be an original but all of which shall constitute one and the same agreement.






