PARTIAL RELEASE
OF SECURITY INTEREST IN IP COLLATERAL

PARTIAL RELEASE OF SECURITY INTEREST IN IP COLLATERAL (this "Partial Release"), dated as of July 15, 2015, from CERBERUS BUSINESS FINANCE, LLC, as collateral agent (in such capacity, the "Collateral Agent") for its own benefit and for the benefit of the Credit Parties (as defined in the Credit Agreement referred to below), to each of Limited Stores, LLC, a Delaware limited liability company ("Limited Stores"), The Limited Stores GC, LLC, an Ohio limited liability company ("Limited GC"), Limited Stores Company, LLC (f/k/a Mod Times Fashion Group, LLC), a Delaware limited liability company ("Holdings") and Eloquii, Inc., a Delaware corporation, and together with Limited Stores and Limited GC, individually, a "Grantor", and collectively, the "Grantors"). Capitalized terms used and not defined herein have the meanings given such terms in the Security Agreement (as defined below).

WHEREAS, reference is made to that certain Term Loan Agreement, dated as of December 20, 2011 (as amended, modified, supplemented or restated and in effect from time to time, the "Credit Agreement"), by and between, among other parties thereto, (i) the Grantors, (ii) Collateral Agent, and (iii) the Lenders (as defined therein) from time to time party thereto;

WHEREAS, in connection with the Term Loan Agreement, the Grantors executed and delivered that certain Intellectual Property Security Agreement, dated as of December 20, 2011, in favor of the Collateral Agent (the "IP Security Agreement");

WHEREAS, in connection with the Term Loan Agreement, Limited Stores executed and delivered that certain Grant of Security Interest in United States Trademarks, dated as of December 20, 2011, in favor of the Collateral Agent (the "Grant", and together with the IP Security Agreement, collectively, the "Security Documents");

WHEREAS, pursuant to the Security Documents, the Grantors (i) granted to the Collateral Agent, for its own benefit and for the benefit of the Credit Parties, a lien on and security interest in, all of the Grantors' right, title, and interest, whether then owned or existing or thereafter created, acquired or arising, in and to the IP Collateral (as defined in the IP Security Agreement) (the "Security Interest"), and (ii) acknowledged and agreed that the Collateral Agent had and should continue to have for its own benefit and for the benefit of the Credit Parties a continuing Security Interest in all of the Grantors' right, title, and interest, whether then owned or existing or thereafter created, acquired or arising, in and to the IP Collateral;

WHEREAS, the IP Security Agreement was recorded with the United States Patent and Trademark Office at Reel 4685, Frame 0641 on December 22, 2011; and

WHEREAS, the Collateral Agent now desires to release its Security Interest solely in the IP Collateral expressly identified in Schedule A.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and upon the terms set forth in this Partial Release, the Collateral Agent hereby agrees as follows:

SECTION 1. Release of Security Interest. The Collateral Agent hereby releases and discharges its Security Interest solely in the IP Collateral expressly identified in Schedule A and any right, title or interest of the Collateral Agent in or to such IP Collateral shall hereby cease and become void. Nothing herein shall be deemed to constitute a release or discharge of the Collateral Agent's Security Interest in any IP Collateral not expressly identified in Schedule A, which Security Interest remains in full force and effect as of the date hereof.

SECTION 2. Further Assurances. At the sole cost and expense of the Grantors, the Collateral Agent shall execute and deliver to the Grantors all further releases and other documents (including without limitation Uniform Commercial Code amendment statements), each in form and substance reasonably satisfactory to the Collateral Agent, to further evidence the release of the Security Interest in the IP Collateral expressly identified in Schedule A.

SECTION 3. Governing Law. This Partial Release shall be governed by, and shall be construed and enforced in accordance with, the laws of the State of New York.
