GRANT OF SECURITY INTEREST
IN UNITED STATES TRADEMARKS

July 20, 2015

FOR GOOD AND VALUABLE CONSIDERATION, receipt and sufficiency of which are hereby acknowledged, THE GREAT ATLANTIC & PACIFIC TEA COMPANY, INC., a Maryland corporation (the "Company") and each subsidiary of the Company party hereto (individually, a "Grantor", and together with the Company, the "Grantors"), each having principal offices at Two Paragon Drive, Montvale, NJ 07645, hereby grants to FORTRESS CREDIT CORP., as Collateral Agent and Administrative Agent, with principal offices at 1345 Avenue of the Americas, 46th Floor, New York, NY 10105 (the "Grantee"), a continuing security interest in all of the Grantors' Trademarks and Trademark Licenses, including those set forth on Schedule A attached hereto (the "Grant"); provided that any United States intent-to-use trademark applications are excluded to the extent and for so long as creation by a Grantor of a security interest therein would impair the validity or enforceability of such intent-to-use trademark applications under applicable federal law; provided that, upon submission and acceptance by the US Patent and Trademark Office of an amendment to allege use pursuant to 15 U.S.C. Section 1060(a), such intent-to-use trademark application shall be considered Intellectual Property Collateral.

This Grant is made to secure the payment or performance, as the case may be, in full of the Obligations among the Grantors, the other grantors from time to time party thereto and the Grantee, dated as of July 20, 2015 (as amended, modified, restated and/or supplemented from time to time, the "Security Agreement").

Capitalized terms used but not otherwise defined herein shall have the meanings assigned in the Security Agreement.

THIS GRANT SHALL BE GOVERNED BY THE LAWS OF THE STATE OF NEW YORK, AND, TO THE EXTENT APPLICABLE, THE BANKRUPTCY CODE.

This Grant may be executed in counterparts, each of which taken together shall constitute one instrument. This Grant may be executed and delivered by facsimile or other electronic transmission, and they shall have the same force and effect as manually signed originals. Agent may require confirmation by a manually-signed original, but failure to request or deliver same shall not limit the effectiveness of any facsimile signature.

This Grant has been granted in conjunction with the security interest granted to the Grantee under the Security Agreement. The rights and remedies of the Grantee with respect to the security interest granted herein are as set forth in the Security Agreement, all terms and provisions of which are incorporated herein by reference. In the event that any provisions of this Grant are deemed to conflict with the Security Agreement, the provisions of the Security Agreement shall govern.

The Grantors and the Agent acknowledge that the exercise of the Agent's rights and remedies hereunder may be subject to, and restricted by, the provisions of the Intercreditor Arrangements. In the event of any conflict between the terms of the Intercreditor Arrangements and the terms of this Grant, the terms of the Intercreditor Arrangements shall control.

Notwithstanding anything herein to the contrary, the exercise of rights and remedies of the Agent and Lenders hereunder is subject to the provisions of the Orders. In the event of any

conflict between the terms of the Orders and the terms of this Agreement, the terms of the Orders shall govern and control.

Upon payment or performance, as the case may be, in full of the Obligations and termination of the Security Agreement, Grantee shall execute, acknowledge and deliver to the Grantors an instrument in writing in recordable form releasing the collateral pledge, grant, assignment, lien and security interest in the Intellectual Property Collateral under this Grant..
