**TERMINATION AND RELEASE OF
SECURITY AGREEMENT (TRADEMARKS)**

This Termination and Release of Security Agreement (Trademarks), (this "Release Agreement"), dated as of May 19, 2015, is made by REGIONS BANK (the "Agent") in favor of DIVERSITECH CORPORATION (the "Company").

WHEREAS, Company and Agent entered into that certain Security Agreement (Trademarks), dated as of July 29, 2011 (as amended, supplemented or otherwise modified from time to time, the "Trademark Security Agreement"), whereby Company granted Agent, a security interest in and to all of Company's right, title and interest in and to the "Property" (as such term is defined in the Trademark Security Agreement), including the Trademarks (as such term is defined in the Trademark Security Agreement) listed on Schedule 1 attached hereto, (the "Security Interest"); and

WHEREAS, the Trademark Security Agreement was recorded (i) with regard to the Trademarks with the United States Patent and Trademark Office on August 31, 2011 at Reel 4615, Frame 0007;

WHEREAS, the obligations secured by said Security Interest under the Trademark Security Agreement have been paid in full or otherwise satisfied; and

WHEREAS, the Agent has agreed to terminate and release its Security Interest and all of its right, title and interest in each of the Trademarks (including the Trademarks listed on Schedule 1 attached hereto), as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

1. Release and Assignment. The Agent hereby discharges, terminates and releases its security interest in all of the each of the Trademarks (including the Trademarks listed on Schedule 1 attached hereto), and the Agent hereby assigns and transfers to the Company, without recourse, all of the Agent's right, title and interest in and to each of the Trademarks (including the Trademarks listed on Schedule 1 attached hereto) and the related registrations and goodwill, effective as of the date set forth above.

2. Further Assurances. Agent hereby agrees to execute, acknowledge and deliver all such further instruments and to take all such further actions as may be reasonably requested or are required in order to more fully and effectively carry out the purposes of this Release Agreement at the Company's sole cost and expense.
