RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF FIRST LIEN TRADEMARK SECURITY

AGREEMENT (this "Release") is made as of July 31, 2015 ("Effective Date") by and between General Electric Capital Corporation, as collateral agent ("Grantee"), and Waddington North America, Inc. and Eco-Products, Inc. (collectively, "Grantors").

WHEREAS, pursuant to the terms and conditions of that certain FIRST LIEN TRADEMARK SECURITY AGREEMENT by and between Grantors and Grantee dated June 7, 2013 (the "Trademark Security Agreement"), Grantors granted to Grantee a security interest in all of such Grantors' right, title and interest in, to and under the United States trademarks and trademark applications listed on Schedule I attached hereto (the "Trademark Collateral"), in each case, together with the goodwill associated therewith;

WHEREAS, Grantor and Grantee entered into the Trademark Security Agreement pursuant to the terms and conditions of (a) that certain First Lien Credit Agreement dated June 7, 2013 (as amended, supplemented or otherwise modified from time to time, the "Credit Agreement"), among WNA Parent Corp., a Delaware corporation ("Holdings"), WNA Holdings, Inc., a Delaware corporation (the "U.S. Borrower"), Polarpak Inc., a corporation organized and existing under the laws of the Province of Ontario, Canada (the "Canadian Borrower"), Par-Pak Europe Limited, a company organized under the laws of England and Wales (the "U.K. Borrower" and, together with the U.S. Borrower and the Canadian Borrower, the "Borrowers") the Lenders party thereto, General Electric Capital Corporation, as U.S. Administrative Agent, U.K. Administrative Agent and Collateral Agent and GE Canada Finance Holding Company, as Canadian Administrative Agent and (b) the First Lien U.S. Collateral Agreement dated of even date with the Credit Agreement (as amended, supplemented or otherwise modified from time to time, the "Collateral Agreement"), among Holdings, the Borrowers, the other grantors from time to time party thereto and the Collateral Agent;

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office ("PTO") on June 20, 2013, at Reel 5053, Frame 0008; and

WHEREAS, Grantors have paid all of their outstanding indebtedness to Grantee.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby terminates the Trademark Security Agreement, and hereby terminates, cancels and releases any and all security interests it has against the Trademark Collateral.


Grantee represents and warrants that: (i) it has the full power and authority to execute this Release; (ii) it has not assigned, transferred, restricted or otherwise encumbered any security interest it has against the Trademark Collateral; (iii) without Grantors' consent, it has not recorded or otherwise evidenced its security interest with respect to any trademark, or registration of an application to register any trademark, or any trade name or assumed name, in each case, of the Grantors, other than the Trademark Collateral.

At the Grantors' sole cost and expense, Grantee shall take all further actions, and provide to Grantors, their successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Grantors to more fully and effectively effectuate the purposes of this Release.
