RELEASE OF SECURITY INTEREST IN TRADEMARKS

This Release Of Security Interest In Trademarks (this "<u>Release</u>"), is dated as of August 4, 2015 by General Electric Capital Corporation, as Secured Party for the Lenders (as defined below), in favor of Del Taco, LLC, a California limited liability company ("<u>Del Taco</u>"). NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Secured Party hereby terminates the Security Agreement and the Grant of Trademark Security Interest and releases any security interest, right or other interest it may have in the Trademark Collateral listed on Schedule A and hereby reassigns any and all right, title and interest it may have in and to the Trademark Collateral without recourse to Del Taco, together with the goodwill of the business symbolized thereby.
