RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL

This RELEASE, dated as of July 21, 2015, is made by Morgan Stanley Senior Funding, Inc., as Collateral Agent (in such capacity, the "Agent" and, in both such capacity and its capacity as Term Loan Administrative Agent, "MSSF") under the Credit Agreement, dated as of October 27, 2014, among Zebra Technologies Corporation, MSSF, JPMorgan Chase Bank, N.A., as Revolving Facility Administrative Agent, and the Lenders party thereto (as amended, restated, supplemented or otherwise modified, the "Credit Agreement"), in favor of Symbol Technologies, Inc., a Delaware corporation ("Grantor") as follows:

WITNESSETH

WHEREAS, pursuant to the Collateral Agreement (as defined in the Credit Agreement), and the Trademark Security Agreement (as amended, restated, supplemented or otherwise modified, the "<u>Trademark Security Agreement</u>"), dated as of October 27, 2014, among the Grantor, certain other grantors party thereto, and the Agent, the Grantor granted the Agent a lien on and security interest in all of its right, title and interest in, to and under the Trademark Collateral (as defined in the Trademark Security Agreement), including, without limitation, the trademarks set forth on Schedule A attached hereto;
