RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”), dated as of August 18, 2015 (the “Effective Date”), is made by Goldman Sachs Bank USA, in its capacity as collateral agent pursuant to the Collateral Agreement (in such capacity, the “Collateral Agent”), in favor of Coyote Logistics, LLC (the “Grantor”).

WHEREAS, pursuant to that certain Collateral Agreement dated as of March 26, 2015 (as amended, restated, supplemented or otherwise modified from time to time, the “Collateral Agreement”), among the Grantor, the other Grantors party thereto and the Collateral Agent, the Grantor granted to the Collateral Agent, in its capacity as Collateral Agent, a security interest in and to certain collateral;

WHEREAS, pursuant to the Collateral Agreement, the Grantor executed and delivered a Trademark Security Agreement, dated as of March 26, 2015 (the “Trademark Security Agreement”), for recording with the United States Patent and Trademark Office;

WHEREAS, the Trademark Security Agreement was recorded by the United States Patent and Trademark Office on March 26, 2015, at Reel 5485, Frame 0886.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby agrees as follows:

1. Defined Terms. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Collateral Agreement or the Trademark Security Agreement, as applicable.
2. Release. The Collateral Agent, without representation or warranty of any kind, hereby releases, discharges, terminates and cancels all of its security interest in the Trademark Collateral, including the Trademarks set forth Schedule I attached hereto, and any goodwill associated therewith, arising under the Trademark Security Agreement. If and to the extent that the Collateral Agent has acquired any right, title or interest in and to the Trademark Collateral under the Trademark Security Agreement, the Collateral Agent, without representation or warranty of any kind, hereby re-transfers, re-conveys and re-assigns such right, title or interest to the Grantor.
3. Governing Law. This Release shall be governed exclusively under the laws of New York, without regard to conflicts of law or choice of law principles.
