TERMINATION OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION OF SECURITY INTEREST IN TRADEMARKS** (this "Termination"), dated as of August 24, 2015 is made by Barclays Bank PLC in its capacity as administrative agent (in such capacity, the "Administrative Agent") for itself and the other Secured Parties (as defined in the Security Agreement referred to below), in favor of Interline Brands, Inc., a New Jersey corporation located at 701 San Marco Boulevard, Jacksonville, Florida 32207 ("Grantor"). Unless otherwise defined herein or the context otherwise requires, terms used in this Termination shall have the meanings assigned to such terms in the Security Agreement (as defined below). Notwithstanding the foregoing, for the purposes of this Termination, "Trademark Collateral" shall have the meaning assigned to such term in the Trademark Security Agreement (as defined below) and shall include, without limitation, those Trademark registrations and Trademark applications listed on Schedule 1 attached hereto.

WHEREAS, pursuant to that (i) certain Pledge and Security Agreement, dated as of March 17, 2014 (as it may be amended, restated, supplemented, waived or otherwise modified from time to time, the "Security Agreement") between the Grantor, the other grantors party thereto and the Administrative Agent and (ii) certain Trademark Security Agreement, dated as of March 17, 2014 (the "Trademark Security Agreement") executed by the Grantor in favor of the Administrative Agent, the Grantor pledged and granted to the Administrative Agent a continuing security interest in and Lien upon all of the Grantor's right, title and interest in, to and under the Trademark Collateral; and

WHEREAS, the security interest in the Trademark Collateral pledged and granted by the Grantor to the Administrative Agent under the Trademark Security Agreement was recorded at the United States Patent and Trademark Office on March 17, 2014, at Reel 5238, and Frame 0154; and

WHEREAS, the Administrative Agent has agreed to terminate, release and discharge its security interest in and Lien on all of the Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration, including the satisfaction of all obligations, indebtedness and liabilities of the Grantor secured by the Trademark Collateral pursuant to the Security Agreement and the Trademark Security Agreement, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby agrees as follows:

1. The Administrative Agent hereby absolutely, unconditionally and irrevocably terminates, cancels, releases and forever discharges all of its Liens upon and security interests in all of the Grantor's right, title and interest in, to and under the Trademark Collateral, including all goodwill associated with the Trademark Collateral, and any and all other security interests or liens that the Administrative Agent or its predecessors, successors, assigns and transferees may have in or to the Trademark Collateral under the Security Agreement or the Trademark Security Agreement.

2. The Administrative Agent authorizes and requests that the United States Commissioner of Patents and Trademarks and any other applicable officer in any successor office or any similar office in any other country record this Termination.

3. THIS TERMINATION AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES UNDER THIS TERMINATION SHALL BE CONSTRUED AND INTERPRETED IN ACCORDANCE WITH AND GOVERNED BY THE LAW OF THE STATE OF NEW YORK, WITHOUT REGARD TO CONFLICTS OF LAW PRINCIPLES THAT WOULD RESULT IN THE APPLICATION OF ANY LAW OTHER THAN THE LAW OF THE STATE OF NEW YORK.
